Senior Adult Amateur & Open - age 18 and up

**Classes:** Split by Youth or Senior divisions but may be combined if entries warrant.

**Friday Schooling** *Haul-in for schooling is available on the Friday afternoon before each show for \$50  
Please indicate on your entry if you would like to haul-in to school the day before the show.*

**Information/Fees:** (Sorry, no refunds after the closing date.)

- **Class Fees:** Senior \$30 Youth (18 and under) \$25
  - **Non-competing horse:** \$50 (just there for experience away from home)
  - **Late Entry Fee,** if postmarked after closing date: \$15 (if room available)
  - **Returned Check Fee:** \$50
  - **Facilities:** Show will be held in indoor ring with custom fiber/sand footing – large dressage ring used; small dressage ring may be used for Intro and Training levels at the discretion of management, outdoor warmup is in sand ring. Lunging in designated fenced round pen only.
  - **Standard dressage rules,** especially regarding equipment
  - **MANDATORY HELMET DUE TO INSURANCE!** USEF standards for helmets will be strictly enforced.
  - **Each Horse /Rider** combination must have a separate entry.
  - **No entry will be accepted without payment.**
  - **Dress code** is relaxed. Boots or half-chaps, safe riding shoes with a heel, neat and clean shirt/jacket with a collar. Appropriate western acceptable if worn over a safety helmet.
- \*\* NO DOGS ALLOWED on Milestone Farms property**

## OHIO LIABILITY RELEASE AND ACKNOWLEDGMENT

I AGREE that I choose to participate voluntarily in the Milestone Farms LLC shows. I am fully aware and acknowledge that horseback riding and equine activities carry inherent dangerous risks of accident, loss, and serious bodily injury. In accordance with the Ohio Equine Liability Act, Ohio Revised Code 2305.321, I do hereby acknowledge the following INHERENT RISKS OF EQUINE ACTIVITIES:

- a) The propensity of an equine to behave in ways that may result in injury, death or loss to person on or around the equine;
- b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- c) Hazards, including, but not limited to, surface or subsurface conditions;
- d) A collision with another equine, another animal, a person, or an object;
- e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other person, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I AGREE THAT: In consideration of Milestone Farms LLC allowing my participation in Milestone Farms LLC hosted or sponsored activities, and/or any other equine activity, under the terms set forth herein, I, the rider, and the parent or guardian thereof if a minor, do (a) agree to hold harmless and release Milestone Farms LLC, and its agents, volunteers, employees, officers, members, premises owners, affiliated organizations, and insurers from legal liability due to any of their negligence or to the negligence or actions of other riders, auditors, clinicians, or spectators, (b) waive any legal claim I or my minor child or ward named below may have against Milestone Farms LLC, its agents, volunteers, employees, officers, members, premises owners, affiliated organizations, and Insurers for injuries resulting from any INHERENT RISKS OF EQUINE ACTIVITIES, as described above and in Ohio Revised Code 2305.321, and (c) agree that I am participating in all equine activities hosted, organized, or sponsored by Milestone Farms at my own risk and assume all risk of damage or injury to my person, horse, or property other than that due to the intentional misconduct of Milestone Farms LLC.
