Bloomfield Police Department Monthly Report for February 2020

This is the monthly report for the Month of February 2020 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, February 2nd at approximately 9:13pm officers executed a traffic stop on Hwy 120 for a defective equipment violation. At the conclusion of the traffic stop a 29-year-old male was issued a traffic citation for defective lighting. Additionally, a charge of operating after revocation and a charge ignition interlock device tampering/failure to install have been forwarded to the Walworth County District Attorney's office.

On Wednesday, February 5th at approximately 12:36am officers execute a traffic stop on Pell Lake Drive in the area of Hwy U for a speeding violation. At the conclusion of the traffic stop a 39-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued traffic citations for speeding and operating a motor vehicle without insurance.

On Wednesday, February 5th at approximately 11:11pm officers executed a traffic stop on Hwy 120 in the area of Hwy H for a speeding violation. At the conclusion of the investigation a 48-year-old female was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for the stop sign violation.

On Sunday, February 9th at approximately 3:33am officers responded to the area of Hwy H and Eagle Road for a report of a vehicle crash. Upon arrival it was determined to be a single vehicle property damage only crash. At the conclusion of the investigation a 37-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for deviation from designated lane.

On Monday, February 10th at approximately 11:32am officers responded to a residence in the 1200 block of Maple Road for a domestic disturbance. At the conclusion of the investigation a 35-year-old female was arrested and confined in the Walworth County jail. Charges of disorderly conduct, criminal damage to property and misdemeanor bail jumping have been forwarded to the Walworth County District Attorney's office.

On Tuesday, February 11th at approximately 5:00pm officers, while at the police department, received a bail jumping complaint. At the conclusion of the investigation a misdemeanor charge of bail jumping was referred to the Walworth County District Attorney's office for a 32-year-old female.

On Wednesday, February 12th at approximately 10:40pm officers responded to Chris's Steelhorse Saloon located on N. Lakeshore Drive for a motor vehicle theft complaint. At the conclusion of the investigation the vehicle was located and recovered in Kane County, Illinois. A charge of operating a motor vehicle without owners' consent has been forwarded to the Walworth County District Attorney's office for a 55-year-old male.

On Sunday, February 16th at approximately 12:55pm officers executed a traffic stop on Park Road in the area of Clover Road for a traffic violation. At the conclusion of the investigation, the driver, a 19-year-old was arrested and confined in the Walworth County Jail. A charge of operating after revocation was forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued traffic citations for failure to wear seatbelt, failure to have passenger wear seatbelt and operating a motor vehicle without insurance.

On Thursday, February 20th at approximately 12:16am officers executed a traffic stop on Pell Lake Drive in the area of Chicago Drive for a traffic violation. At the conclusion of the traffic stop a 22-year-old female was issued traffic citations for operating an unregistered vehicle, operating after suspension and operating a motor vehicle without insurance.

On Thursday, February 20th at approximately 11:48pm officers executed a traffic stop on Hwy 50 in the area of Eastside Road for a speeding violation. At the conclusion of the traffic stop a 30-year-old male was issued a non-traffic citation for possession of marijuana. Additionally, the driver was issued a non-traffic citation for disorderly conduct with a motor vehicle.

On Sunday, February 23rd at approximately 8:22am officers responded to a residence in the 1400 block of Cedar Road for a domestic disturbance/keep the peace complaint. At the conclusion of the investigation charges of disorderly conduct and criminal damage to property have been referred to the Walworth County District Attorney's office for a 36-year-old female.

On Tuesday, February 25th at approximately 11:29pm officers attempted to execute a traffic stop on a gocart type vehicle traveling on Tombeau Road in the area of Lakeside Drive. At the conclusion of the incident a 49-year-old male was arrested and confined in the Walworth County jail. Charges of operating a motor vehicle while intoxicated 5th offense, vehicle operator flee/elude a traffic officer and ignition interlock device tampering/failure to install have bene forwarded to the Walworth County District Attorney's office.

On Wednesday, February 26th at approximately 8:00pm officers responded to a report of a reckless driver on Hwy H in the area of Townhall Road. The vehicle was located, and a traffic stop was executed. At the conclusion of the traffic stop a 60-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense.

On Wednesday, February 26th at approximately 11:44pm officers executed a traffic stop on Hwy H in the area of Clover Road for an equipment violation. At the conclusion of the traffic stop a 62-year-old male was arrested for operating a motor vehicle while intoxicated. A charge of operating a motor vehicle while intoxicated 3rd offense has been forwarded to the Walworth County District Attorney's office.

During the month of February 2020, the Bloomfield Police Department responded to 825 calls for service compared to 721 calls for service during the month of February 2019. During the month of February 2020, the police department affected 139 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 91 arrests during the month of February 2019.
