ORDINANCE NO. 4, 1962

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY
TO THE TOWN OF CLOVERDALE, INDIANA.

SECTION I: Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana to-wit: Part of Northeast Quarter of Section 1, Township 12 North, Range 4 West, to-wit: Beginning at a stone marked ISS 1916, 786 feet south and 599 feet west of said Northeast Quarter, which stone is located on the West line of West Street in the Town of Cloverdale, Indiana; thence from said beginning point south 270.54 feet to an iron pin located on the west line of said West Street; thence west 233.2 feet to an iron pin; thence north parrallel to the East line of said Northeast Quarter Section 649.42 feet to an iron pin located on the north property line of the property now owned by Glen D Horn; thence eastwardly parallel to the north line of said Northeast Quarter Section 205.2 feet to a stone; thence southeastwardly along the west line of said West Street a distance of 374.88 feet to the place of beginning. Containing 3.41 acres more or less. The above described real estate is recorded in Plat Book ---, Page 104H.

SECTION II: That this ordinance shall be in full force and effect from and after it's passage and legal publication there- of according to law.
