1. A Guardian Ad Litem is necessary to represent the best interests of minor children Ty Riley Chittick and Dillon Cash Chittick (the “Minor Children”) in settlement negotiations between the Receiver and the Estate of Denny Chittick because of the potential for a settlement to affect the interests of the Minor Children and because of the complexity of the issues involved.

2. The Receiver and the custodial parent of the minor children, Ranasha Dawn Chittick, have both consented to the appointment of a Guardian Ad Litem.

IT IS THEREFORE ORDERED appointing Paul J. Theut as the Guardian Ad Litem.

IT IS FURTHER ORDERED that the Guardian Ad Litem shall have authority to review and evaluate any settlement proposed by and between the Receiver and the Estate of Denny Chittick, to the extent such settlement affects the interests of the Minor Children.

The Guardian Ad Litem has a duty to act in the best interest of the Minor Children and avoid engaging in excessive or unproductive activities. The Guardian Ad Litem has limited immunity consistent with Arizona case law applicable to Officers of the Court as to all actions undertaken pursuant to the Court appointment and this Order. Any alleged impropriety or unethical conduct by the Guardian Ad Litem shall be brought to the attention of the Court in writing.
