2. The nominator must complete a nomination form, providing specific information about the nominee.
3. Each applicant must be nominated in one category.
4. All information submitted for the "Yes I Can" awards must be legible.
5. All submitted information becomes the property of The Ohio Council for Exceptional Children.
6. Nominations must be postmarked no later than March 15, 2018.

\_\_\_\_\_ Academics- achievement in a particular subject area such as math, science, reading, social studies, language arts, foreign language, etc. or a high level of achievement on standardized tests, etc.

\_\_\_\_\_ Arts- achievement in a particular medium such as music, art, drama, dance, or written expression, etc.

\_\_\_\_\_ Athletics- achievement in motor skills or a particular athletic activity through a setting such as intramurals, Special Olympics, physical education classes, or after school athletic activities.

\_\_\_\_\_ School and Community Activities- contributions to school or community through activities such as volunteer work, youth work, clean-up campaigns etc.

\_\_\_\_\_ Extracurricular Activities- achievement in organized activities in groups like the Boy/Girl Scouts, church, clubs, or other activities.

\_\_\_\_\_ Transition- achievement in mastering activities for daily self-efficiency such as personal hygiene, cooking, use of public transportation, or employment skills in a workplace or the competitive job market.

\_\_\_\_\_ Technology- significant achievement through the use of computerized devices and equipment.

\_\_\_\_\_ Self-Advocacy- achievement in assuming practical responsibility for oneself, using, knowledge of legal rights, advancing one's goals, and/or effective in obtaining appropriate accommodations for oneself.
