o Carpooling-According to legal advice, Choice Academies cannot assist in organizing carpools. However, parents may create and share a Google document listing cross streets to formulate carpools.

• Parking:

o Preschool is looking into the option to have a car drop off from 7:40-8:05 which will eliminate the need for

parents to park and walk their children in during the busiest drop off time.

o The business office is still waiting to hear from the owner of the property of the vacant lot just north of the school. The potential opportunity is that the land will be graded and the land will be rented to Choice Academies for additional parking.

o With the results of the survey, Choice Academies will continue with the original plan of the grade configuration of ATA (K-8) and JP (9-12).
