BURNING ON YOUR OWN PROPERTY

If you plan to do yard waste burning on your property you **must** get a burn permit beforehand from Benton County. (If you don't and a fire truck comes out because someone reports smoke at your property, you will be charged for the fire service call.) Call **Benton County at 479-273-5530.** Burn Ban info can be found on our website: www.lbvca.com. (Burning of construction materials is prohibited.) *Do not leave smoldering fires unattended!*

CLEANING UP YOUR PROPERTY:

Please remember: Be a good neighbor and rake out leaves and tree debris from your ditches and culverts to prevent water run-off problems, and either burn them or haul them away. If you hire someone to rake leaves or clear other yard waste from your property be sure to tell them to NOT push it into a ditch or culvert or into the street. The property owner can bring them to the Village collection site on Arabian Drive or take it to Inland Waste Service (479-878-1384) for disposal. You will be charged a clean-up fee if LBVCA has to clean out your ditch.

INJURED OR DEAD ANIMALS: To report an injured or dead animal (deer, raccoon, etc.) and have it removed from a <u>state</u> culvert or <u>state</u> road, contact the **Arkansas Game & Fish Department** at 1-866-253-2506. (They'll need the street address of where the animal is located.) If you find a dead animal or deer parts on your property (left behind by hunters or coyotes), you may bury them but <u>NOT</u> burn them (according to the AR Dept. of Environmental Quality).

The Benton County Roads Dept. and Sheriff's Dept. state they have no program in place for picking up dead deer from county roads or culverts. If the animal is lying in a culvert, notify the AR Dept of Environmental Quality at 1-888-233-0326.

VILLAGE ROADS:

Green and **Blue** street signs in the village are county roads. If you live on a road with potholes or ruts, **call Benton County Roads (479-271-1052)** to have it repaired. You do not need to call the Village Office or wait for a Board meeting to report it.

SPEED LIMIT & PARKING in LBV: The speed limit throughout the Village is **20 or 25mph** and is enforceable by the Benton County Sheriff's dept. *There is <u>no</u> onstreet parking throughout LBV*.

Airstrip Report

This News Letter copy as well as the past two articles have been provided by Steve Bray, who is the Lost Bridge Village Airstrip Manager. Thank you Steve for your submissions!!

The subject for this newsletter article is runway safety and courtesy, directed to our pilot community. Next time, I will address non-aviation users. A few safety and courtesy guidelines can go a long way towards keeping the airstrip safe for everyone. Our runway is a valuable amenity and is used for much more than aircraft takeoffs and landings. Many members and their guests use it for various exercise and recreation purposes.

Pilots:

- When departing the airstrip on 13, please climb to the opposite numbers before turnout. I recently got a call from a resident concerned that a plane turned North around midfield and was in danger of hitting the power lines near the member's home. I did not witness the event, but suspect the pilot turned early after reaching what (s)he deemed a safe altitude. I examined the area and determined the power lines are near and below the tree line and do not constitute an unusual hazard to normal aircraft operations. Pilots should keep in mind that persons on the ground can easily misjudge the height of a nearby aircraft in relation to other objects, particularly when startled by an aircraft not acting as anticipated.
- Expect both 2- and 4-legged wildlife on the runway as well as numerous buzzards in the vicinity. Most wildlife will clear the runway with a single low pass overhead, but I recently needed to make 3 low passes for a human and dogs to get the message. If you make a low pass or go-around, keep it above the trees and give yourself plenty of room to climb and turn to avoid terrain beyond runway 31.

BUILDING NEWS Architectural Control Committee BUILDING PROJECT GUIDELINES

We here at the Architectural Control Committee (ACC) are consistently impressed with the increased interest in building additions and even home builds in this rather distressed economy. It's readily apparent that the rush to rural areas is still active.

In that connection, we urge our residents to please contact us prior to any project in regards to your property. We would much rather tender our appreciation to you for coming to us and finding out that your project doesn't require our oversight, than having to notify you that you have violated the Building Standards & Practices Guidelines, thereby being charged a double fee for the application.

If we could charge a doubled permit fee to the CoronaVirus instead, we sure would. In lieu of that, we wish to say THANK YOU to all the front-line folks still working to keep our society in motion, and in getting the vaccine phase started.

Our next meeting is scheduled Monday <u>February 1st, at 4 PM</u>, in Village Hall, (lower-level Community Building below the office) practicing social distancing protocols; mask wearing is mandatory.

Also, we would like to again ask for property owners with an interest in becoming a Committee member to contact the office. We presently have no committee representation from the Cedar Forest area and try to maintain a diverse presence.

For those who are thinking of starting a construction project, or those in the throes of one and unsure what the next step is, see below:

The Guidelines/Procedures for Building Applications are as follow:

Property owner submits proposed building plan application to LBVCA ACC, whom reviews these plans for <u>Covenant</u> <u>Compliance</u>, and then approves/denies applications using Building Standards & Practices as a guide. Building Project Checklist is completed by property owner, and appropriate fees and performance deposits are collected.

Benton County Development (Building Safety Division) will only issue appropriate Building Permits after receiving application approval from LBVCA ACC.

After project is completed, ACC follows up and reviews/approves/denies for <u>Covenant Complianc</u>e. When the CO (Certificate Of Occupancy) is issued by a Benton County Building Inspector, and final approval is then obtained from the ACC, the property owner may then apply to the ACC for a refund of their Performance Deposit.

Library Hours Change as of February 1, 2021

As of November 2, 2020, the Library hours of operation will be between 9:00am and 7:00pm on Monday, Wednesday, and Thursday. Starting February 1, 2021, the Library will also be available on Saturday 9am-7pm.

These posted hours of operation are for checking out or returning library materials only. Please do not bring new materials/donations at this time.

The LBV Office remains closed without a scheduled appointment. If you need to interact with office personal, please call 479-359-3204 to schedule an appointment.

User Compliance

- 1. Since the library is not staffed please use your own sanitizer/wipes when opening/closing the front door so you are not transmitting any virus from your hands, car, etc. to library materials or others.
- 2. You are always required to provide and wear your own face mask upon entering the building.
- 3. It is strongly recommended that you provide and use your own gloves because you will be touching library materials.
- 4. Your door access code will be activated to enter the Community Building during these days and hours of operation.
- 5. Practice social distancing (6-foot separations) when others are present.
- Maximum occupancy within the building is four. If there are four people already inside the building or library when you arrive please exit and go outside and wait until one departs. <u>This is an honor system.</u>
- 7. Computers in the library and lobby entrance will not be available for use and will be taped off.
- 8. <u>The Bathroom will **NOT** be open</u> at this time.
- 9. Bring your own pin/pencil for signing out library materials as none will be provided.




What is Neighborhood Watch?

Neighborhood Watch members and captains are simply concerned neighbors that help keep an eye on things and report issues to the proper authorities, whether that is law enforcement or the Board members. Without Neighborhood Watch many issues and concerns would go unreported and unresolved because the proper authorities are simply unaware of them. Neighbors and members of the community are more easily able to recognize when there is suspicious or criminal activity occurring because they are already familiar with who lives in the area, what vehicles belong there, and what normal activity is, so when something out of the ordinary occurs or a new person or vehicle is seen in the area they recognize it as unfamiliar.

Neighborhood Watch members are also helpful in reporting other issues, such as properties that need cleaned up, streets that need repaired, streetlights that are burned out, storm damage to individual properties or to community areas, and so much more. Members really are the eyes and ears of our community! And their willingness to address issues properly makes our community a better place!
