

Judge – Daniela Koontz (www.danielakoontz.net)

Daniela Koontz is an artist and art educator living in Houston, Texas. She has exhibited her work at The Art League of Houston, Lawndale Art Center, and Front Gallery. Koontz's drawings are a mix of traditional still-life painting and the type of illustrations you might find in an academic journal, but her sensibility is a bit Pop. Using the drawing techniques and realism of botanical or archaeological illustration, she makes lists of like objects and groups them together to carry new meaning. The arrangement is often humorous, and sometimes poetic. Working on paper lends the work an intimacy that you might find in the rare books section of a library. The work is meant to be thoughtful and quiet. She is part of the collective at Box 13 ArtSpace, Houston, Texas where she maintains a studio practice. For the last 16 years she has been teaching High School for Alvin ISD.

Artists

Open to all artists over the age of 15, regardless of membership status.

Entries

Artists may enter up to **three** works in any medium. This is a juried show, which means your work might not be accepted. Those works accepted can be for sale but must remain at the gallery for the entire exhibition period.

Works must be:

1. Created in the last 4 years and not previously accepted in a juried show at the Galveston Art League.
2. Original work of the artist who physically integrates/manipulates every component of the original concept and design.
3. Installation ready with mat, finished edges, cabled/wired frame (**NO SAWTOOTH HANGERS OR HOOKS**), glass, Plexiglas, or acrylic, and hanging device in place where appropriate. Framed works larger than 24 inches in any direction must use Plexiglas or acrylic. See website for full description of criteria.
4. Not to exceed 4' X 5' and all work must be able to be carried and/or hung easily by two people.

Artists must adhere to the above criteria and the published dates and times. Works that do not meet these criteria will not be hung, even if inadvertently accepted into the show. If unable to make a scheduled pick-up time, artists must inform the gallery and arrange for pickup or works become property of the Art League.

Entry Fees -- Entry fees are non-refundable.

Members - \$15 each for first 2 entries, \$5 for third

Non-members - \$20 per work

Art Categories

5 Categories by medium and/or technique

1. Work on canvas or panel
2. Work on paper
3. Photography
4. Mixed media, wall-hung (e.g., collage, fiber, assemblage)
5. 3-dimensional, free standing (e.g., sculpture, art dolls, assemblage, pottery, porcelain, glass, wood, metal)

Drop-Off Guidelines

The Galveston Art League is excited to open our doors with an upcoming juried show. We want to re-assure you that we are doing everything we can to follow the CDC guidelines and the Galveston County health department's suggestions for a retail establishment. To keep everyone safe, we ask that you comply with the following guidelines for delivering art to the gallery.

- Maintain a safe social distance of at least 6 feet from other persons.
- Everyone must wear a mask while inside the gallery
- Work will be accepted by appointment on Sunday, January 24; call Sharon Jones 409-682-3515 to get an appointment **time**. We highly encourage you to drop off early to avoid waiting in line on Monday since we will comply with state-mandated guidelines.
- Individuals who bring in work on Monday, January 25 will need to maintain a safe social distance of at least 6 feet from others and be prepared to wait outside until it is your turn to come inside
- All paperwork must be filled out and forms attached to the back of artwork **prior** to arriving at the gallery, printable forms are included in the prospectus
- Enter the gallery through the main entrance at 2117A Postoffice
- Please plan to arrive, drop-off art, and leave; there will be no opportunity to visit or to browse art while you are in the gallery
- The county is limiting the number of people who can gather at one time. So please, understand if we ask that you wait outside until it is your turn to come inside
