MTC204/2013 Chairman's Welcome and Remarks:

The Chairman Cllr Lees-Hamilton welcomed everyone in

attendance

MTC205/2013 Public Question Time:

Steve Benson from Project Mirfield asked to speak on several issues. Cllr Lees-Hamilton explains to Mr Benson that Standing Orders stipulates each person can speak once only in respect of an item on the agenda for a maximum of 3 minutes. At this point Mr Benson got up to leave. Cllr Lees-Hamilton explained that there was an item on the agenda relating to one of Mr Bensons issues MTC212(4) if he wished to address it. Mr Benson confirmed that he would and that Project Mirfield have members actively obtaining signatures for a petition against the development and asks what Mirfield Town Council are doing about this. Cllr Lees-Hamilton assured Mr Benson that if and when a planning application is sent to Kirklees MTC will do all in its power to fight such a development but until this time there is nothing to oppose. Clirs T Hirst and Pinder agree with Cllr Lees-Hamilton. Mr Benson states that Project Mirfield would like a 7.5 ton weight restriction on access roads to the development. Cllrs Pinder and Lees-Hamilton inform Mr Benson that this will not stop a development and that the developers would obtain permission. Cllr Lees-Hamilton reads an email regarding Kirklees Planning. Kirklees intend to submit a Local Planning Strategy early 2016 with a view to adopt early 2017 until then no LDF is in place to stop developers. Mr Benson asks if MTC have a plan to fight development at Balderstone. Cllr Lees-Hamilton confirmed that MTC has a plan and had in the past fought a development at Mirfield 25 and a proposed development at Balderstone in 1999 and won. Mr Benson became aggressive and

demanded of Cllr Lees-Hamilton if MTC were going to stop the development. Cllr Lees-Hamilton said MTC would fight it. Mr Benson demanded again if MTC would stop it. Cllr Lees-Hamilton reiterated that she had said MTC would fight it but does not have legal powers to stop it. Mr Benson angrily departed the meeting at 7.45pm.

MTC212/2013 Planning

- 1. To consider *planning applications received from Kirklees Council. 2014/90326 & 2014/90375 No Objections/Comments 2013/94023 Former Swan Inn Cllr Lees-Hamilton stated that the pub was an eyesore as it stands but the application that has been submitted is inappropriate for this historical end of Mirfield and out of character with the existing street scene. Cllr T Hirst commented that there were plenty takeaways in the vicinity and a supermarket would cause traffic congestion. Cllr Lees-Hamilton Proposed that MTC object on the grounds of highway safety, visual impact, detrimental to the environment & local residents and not in accordance with the village design statement. Cllr Mapplebeck Seconded and commented that there should be numerous records of accidents when this was a public house due to the junctions at Church Lane, Steanard Lane and Boat Yard Vote: All in favour

- 3. Mirfield Moor No Update keep on agenda
- 4. Balderstone Hall Lane No planning application. Decide course of action if and when submitted.
- 5. Darren Aveyard thanks Mirfield Town Council for all its help with planning in Mirfield and the Ben Bailey development. He confirms that until a planning application was submitted that the group had nothing to fight. Darren confirms that members of Lady Heton Action Group have found discrepancies within Section 4.28 Policy BE12. Policy states 21m from existing building but Kirklees internal guidance document states from the original boundary excluding extensions etc., which means more house builds on plots of land this also means that houses can be built much closer together than the stipulated 21m, this is detrimental to living amenity. Cllr Lees-Hamilton said it looked like it had been approved as a clarification but this had been amended to policy and that MTC should fight on this basis as the committee have changed policy not just clarification. Darren confirms that this would reduce the proposed amount of builds considerably. Martin confirms that he has checked other Ben Bailey sites and that they have built on this basis and he is concerned for residents safety as too many houses. Cllr Lees-

Hamilton states that Kirklees have used this policy as argument for other developments MTC has objected to. Cllr Hamilton asked Martin if this was true of all developers or just Ben Bailey. Martin confirmed that he had looked at other builders sites and it appeared to be the same. He also commented on how the amount of extra residents would impact on a town's infrastructure. Cllr Armitage comments that Britain builds the smallest houses in Europe, that builders make them smaller to fit more on plots. Cllr Lees-Hamilton sums up that Lady Heton Action Group have done an excellent job and wishes that all action groups were so proactive and diligent. All Clirs present agree to support Lady Heton Action Group and Clir Lees-Hamilton asks administrator to contact all absent Clirs and ask them to support via email to Peter Morgan. Cllr Pinder Proposed this be added to the agenda for next meeting Clir Lees-Hamilton Seconded Vote: All in favour. Cllr T Hirst Proposed to reinstate Standing Orders Cllr Pinder Seconded Vote: All in favour.

1. Mirfield Public Toilets – Cllr Pinder notifies council of a meeting with Cllr Lees-Hamilton and Tracy Martin from 'Well Polished' cleaning company. A copy of the cleaning quotation is viewed. Cllr Pinder confirms that this is a very competitive quotation from a capable company who will provide all cleaning products and confirms that the Working Party agrees. Cllr Pinder Proposed that in view of this MTC should proceed with quotation and ask 'Well Polished' to prepare a contract Cllr Mapplebeck Seconded Vote: All in favour Cllr Lees-Hamilton thanks Cllr Pinder for providing the cleaning products to date.
