Did you know that nearly half of the materials ending up in landfills can be composted? Did you know that collection of food scraps, food-soiled paper and yard trimmings at the curb helps keep valuable materials out of the local landfills, reduces harmful greenhouse gases and helps Austin get closer to Zero Waste by 2040.

If you are currently composting at home, that is marvelous! Congratulations! Keep doing that! Remember, there are many items accepted in the City of Austin green organics cart that are not suitable for a residential compost pile. For example, meats, poultry, seafood, dairy products and bones should not be composted at home. You are encouraged to add these items to your green cart each week!

The current monthly charge of \$1 will likely increase to \$4 by 2020. Such a small amount to pay for such a great contribution to saving the planet! You can "opt out" of using the cart by calling 3-1-1 to have it picked up, but you cannot "opt out" of the monthly fee. So, why not put that green organics cart to good use? Help save our beautiful planet Earth!!

Update on Gas Line Street Construction Project

David Risher's last conversation with Robert Tabor was in late December. He is the Texas Gas Service project manager coordinating with the contractor, H&S Construction, Inc. He has not responded to David's latest call. Mr. Tabor had indicated that the recent rains had slowed or stopped progress on the project during December. He said that he appreciates the neighborhood's patience. He could not commit to any specific date for completion of the phase covering Coronado Hills Drive from Brookhollow to Berkman. David indicates that we should probably not expect to see the removal of any barricades blocking Glenhill and Barcelona before March.

Texas Depart of Transportation Department Update!

The E. 51st Street roundabout is scheduled to open mid-February. There will still be work done on the center to complete, but vehicles will be able to use and take advantage of the roundabout. TxDOT will also have a night-time rolling road block of the south bound I-35 main lanes to remove an existing overhead sign bridge.

They will begin a 24-7 operation on Thursday, February 8, 2018, and open one lane of the multi-lane roundabout over the weekend of Saturday, February 11th. Their goal is to have a single lane roundabout open by the Monday, February 13th, morning commute. The project team will continue to work with contractors and residents to minimize the disruption to regular traffic as we transition into the new intersection.

For this work to be completed over the weekend of February 8th, traffic will be detoured in various patterns during off peak hours. Beginning Thursday evening all traffic:

South bound frontage road will be diverted away from the 51st Street intersection by way of the new Collector Distributor.

East bound 51st Street traffic will be allowed for local traffic only. Thru traffic will be detoured via Airport Blvd.

West bound traffic will be accommodated during peak traffic hours Friday morning. During non-peak traffic hours various detours and closures will occur.

The remainder of the roundabout is to be opened later this spring.
