*Supervisor Thelen called the monthly meeting to order
with the Pledge of Allegiance.*

*Approval of Agenda : Clerk Smith asked that Township
expenditure resolution be added to old business. * motion
by Graham to accept the agenda as presented with the
added amendment. *Seconded by Kindel *Motion passed.*

*Reading and Approval of Prior Months Minutes: Clerk
Smith asked the Board if she could read the minutes due
to the previous meeting that was lengthy and information
that needed to be reported correctly. Minutes were read
and discussion was that Treasure Roof to go over minutes
for punctual mistakes before the minutes were put on the
web. * Motion by Graham to go forth with Smith's*

request and to accept the minutes as read *Seconded by Kindel * Motion passed.

Treasurer's Report: The Treasurer's report was given by Roof starting with the Balance and Profit and Loss Sheets. ACH, EFTPS and checks 14761-14775 be approved for payment. Clerk Smith asked to void check # 14769 she would like to inquire with other Townships to see what they pay to MTA for their yearly dues.

Treasurer Roof also reported that our financial institution is charging a fee when transaction investments take place. It was a fee of \$30.00 but Roof got it down to \$20.00. * Motion by Graham to accept report and to pay said bills and to void check 14769. *Seconded by Kindel *Motion passed

Clinton County Sheriff Report: E-mailed monthly report was presented by Clerk Smith. Board discussion

CAASA Report: The new assistant director Eugene Howe has become a real asset to the organization. Director

Weber is still working hard to get the County Paramedic program established. A possible hire might be in the future to do their own billing for their service .

Assessor Report-Beth Botke: BOR will be July 22nd, 2025 10am at the Township Hall. Botke has been working with the County to see if building permits can be handled at a faster pace. Botke is also pleased that Clinton County Planning and Zoning is starting to become better organized

Correspondence: Clerk Smith recieved information from Fire Chief Douglas on how to get your fire permits, they are no longer available at the SJ Police Department.

Details will be on our website. Drain commissioner Hansen sent the Township notice of where spraying will take place. A card was sent to April at the SJ Police Department for her retirement.

** Road Report: CCR has agreed to refund the full amount of the Townships funds to solve the Scott Rd. situation. Mi. Paving will be doing the renovation, when completed we will receive the funds. The Township will be handling our own road graveling ,with Gravel from Carmeuse/Schlegel renting a grader and Trustee Kindel will be doing the grading. Before the Township can proceed with all of this there has to be permits,*

insurance certificates and spending the road millage. The weather has been supplying us with rain so the 2nd application of chloride will not be done and we will see what September weather brings before we order the application.
