

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY
TO THE TOWN OF CLOVERDALE, INDIANA

SECTION I: Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and the same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana to wit:

Situate in the State of Indiana, County of Putnam, and being a part of the North half of the Southeast quarter of Section 1, Township 12 North, Range 4 West of the Second Principal Meridian more particularly described to-wit:

Beginning at a point on the North line of the Southeast quarter of Section 1, Township 12 North, Range 4 West which point is 1,119.32 feet East of the Northwest corner of said Southeast quarter; thence 224.83 feet East with said North Line; thence South 150 feet; thence West 224.83 feet; thence North 150 feet to the point of beginning containing .76 acres more or less.

SECTION II: That this ordinance shall be in full force and effect from and after it's passage and legal publication thereof according to law.

PETITION FOR ANNEXATION

To: The Members of the Board of Trustees
of the Town of Cloverdale, Indiana.

We, the undersigned owners of Real Estate situated outside the Corporate Limits of the Town of Cloverdale, Putnam County, Indiana, but adjacent and contiguous thereto, hereby petition the Town Board of said Town of Cloverdale to have annexed to said Town of Cloverdale the following described real estate, to-wit: Beginning at the Northeast corner of the Northwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 1, Township 12, 4 range; thence west 224' feet, thence south 150 feet; thence east 224 feet; thence north 150 feet to point of beginning.

We, further represent that this petition bears the signatures of at least Fifty-One (51) per cent of the persons owning property in the territory sought to be annexed and hereby request a special ordinance be enacted by the Town Board of the Town of Cloverdale annexing the above described territory contiguous to said Town of Cloverdale. Also we understand that we will not demand Sewage Lines be run through this area and this will be left to the Town of Cloverdale, as to when it will be feasible to do so, and that the legal requirements as prescribed by law will not be enforced on this utility.
