DESCRIPTION : INTERIOR EGGSHELL LATEX ENAMEL offers an extremely high quality interior finish with a velvet finish that resists dirt and staining. Will withstand repeated washing and can be applied on all previously painted walls, ceilings and trim. Desired colors can be obtained by using all purpose colorants.

CLEAN UP: Warm soapy water.

APPLICATION: Stir thoroughly before use. Apply by roller, brush or spray. Apply at temperatures above 50°F and to dry surface. Surface should be clean and free from dust, dirt, grease and peeling paint.

New surfaces, prime as follows:

Plaster, drywall, textured or masonry surfaces – use 1035 1450 Low VOC, Low Odor PVA Undercoat.

Wood – use suitable wood primer.

Metal – use suitable metal primer.

Prime smoke and water soluble stains with STAIN KILLER. KEEP FROM FREEZING, store at room temperature.

SPREADING RATE: 400-450 square feet per gallon, subject to surface porosity, texture and application method.

DRYING TIME: Dries in 1-2 hours (dust free), recoat 4 hours. Excessive humidity, low temperature, failure of air movement and thickness of finish may affect drying time.
