With only a few weeks left in 2020, Hillsborough County's Pet Resource Center would like to see the shelter empty over the holidays. As part of the Home Before the Holidays promotion, PRC officials are encouraging residents to adopt or foster these dogs and cats to help end 2020 in the best possible way.

The Foster Express program can be a wonderful way for pets to get a much-needed break from life in the shelter. It relieves stress, provides the PRC staff with in-home observations that can make a dog or cat more adoptable, and potentially helps find them a forever home. Anyone can foster a dog or cat for a week or up to two months – just long enough to welcome a foster pet in to help ring in the holidays. You can find photos and other information about all available pets at [HCFLGov.net/ADOPT](http://HCFLGov.net/ADOPT). Once you find a foster friend, submit a request at [HCFLGov.net/AtYourService](http://HCFLGov.net/AtYourService).

The Pet Resource Center, 440 N. Falkenburg Road in Tampa, is also a popular place for adoptions. All adoption fees are currently waived, and residents need only make an appointment to meet their future furry best friend at the shelter. All pets are registered, vaccinated, and spayed or neutered prior to adoption. Appointments can be made online or by calling (813) 744-5660. Appointments are available from 8 a.m. to 5 p.m. Monday through Friday, and other times if available.

The Pet Resource Center is also offering curbside pick-up and delivery of adoptions via the Curbside Cuddle Program.

The Pet Resource Center also has a working cats program that features cats that might not be appropriate for an indoor environment but are ideal around barns, warehouses, and homes on large properties.

## VA Partnership Helps Secure Housing for more than 4,000 Homeless Veterans

WASHINGTON — The U.S. Department of Veterans Affairs (VA) announced today their partnership with Veterans Matter has helped more than 4,000 Veterans exit homelessness and move into permanent housing since 2012. The U.S. Department of Housing and Urban Development and VA's Supportive Housing program, known as HUD-VASH, works with Veterans Matter to help Veterans experiencing homelessness and who qualify for rental subsidies to cover the cost of security deposits. "Collaborations with organizations like Veterans Matter is fundamental to achieving our goal of ending homelessness among Veterans," said VA Secretary Robert Wilkie. "We celebrate the more than 4,000 Veterans that have stable housing as a result of selfless acts of kindness by people who believe every Veteran deserves a place to call home." From 2012 to 2016, the partnership helped to house 1,000 Veterans and has since assisted 3,000 additional Veterans, an increase of 200% during the past four years. Veterans who receive this financial assistance are able to move into approved housing quickly, often because Veterans Matter is able to provide the security deposits to the landlord within 24-48 hours. Veterans Matter is a program of the non-profit organization 1-Matters.org. Established in 2012, the program removes financial obstacles to securing stable housing for Veterans experiencing homelessness in 25 states and the District of Columbia. "As a nation, we have an obligation to help Veterans who fall on hard times," said Ken Leslie, who founded Veterans Matter and once was homeless. "Our partnership with VA demonstrates how the public and private sectors can unite to help Veterans exit homelessness and reintegrate back into their families and communities."

The HUD-VASH program is a collaboration between HUD and VA that combines HUD housing vouchers with VA supportive services such as employment assistance, health care, mental health treatment and substance use counseling. The program enrolls more Veterans who have experienced long-term or repeated homelessness than any other federal program.

**Board of County Commissioners Hybrid Meeting  
Format Puts COVID-19 Safety Measures First**  
*Public participation for these meetings will remain virtual*

The Hillsborough County Board of County Commissioners (BOCC) will hold its first regular meeting featuring a new blend of an in-person quorum and virtual public participation on Thursday, Nov. 12 at 9 a.m.

Commissioners will be meeting in a socially distant setting in the second floor boardroom at County Center. To provide a safe meeting environment in the midst of the COVID-19 coronavirus pandemic, participation by non-essential staff, presenters, and the public will remain virtual via audio or video. The hybrid format also allows for some Commissioners to participate virtually as long as a voting quorum is present in person. A quorum is defined as the minimum number of members of an assembly that must be present at any of its meetings to make the proceedings of that meeting valid.

**How to make public comments:**

The BOCC sets aside 45 minutes at the beginning of regular BOCC meetings to hear from the public. Comments also are accepted during scheduled public hearings on the agenda. Persons who wish to address Commissioners should submit a speaker signup form no later than 8:30 a.m. on the day of the meeting. The form contains instructions on how to participate virtually.

Audiovisual presentations such as Power Points, digital photos, audio, and video files for public comments are not accepted at this time. Presentations may be submitted to the Clerk of the Circuit Court for insertion into the official record by sending to [boccrec@hillsclerk.com](mailto:boccrec@hillsclerk.com).

People who wish to submit written public comment for the meeting and do not wish to speak can email [boccrec@hillsclerk.com](mailto:boccrec@hillsclerk.com). Those emails will be entered into the official record.

The hybrid meeting format is the result of extensive research and work by staff from several County departments and the County Attorney’s Office. Hillsborough County will continue to conduct all public meetings with the safety of the public and staff in mind.

This 1965 photograph of the Atlantic Restaurant is at 3910 East Adamo Drive near the Atlantic Coastline Railroad Building. Look closely - can you see the vintage locomotive parked on the highway just past the restaurant? This was near the entrance for the railroad offices on Adamo/Highway 60 and the view is looking east just past 38th Street. When this photo was taken, a cup of coffee was only .05-cents and you could buy an entire breakfast of eggs, bacon, hashbrowns, toast and grits with coffee - for just \$1.00!! On the lunch menu for \$1.00 you could get a double-cheeseburger, fries, salad and dessert! Soft drinks were .10-cents and shakes were just .20-cents!! 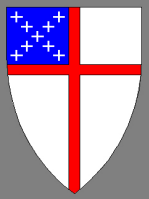

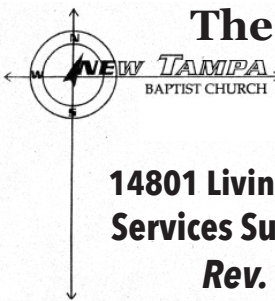

## Show Goes On, with Help from Hillsborough County

Events industry, hit hard by pandemic-related economic slowdown, receives financial boost

Caterers, performers, art exhibitors, and other events-industry professionals have struggled to find work during the pandemic.

Their livelihoods depend on bringing people together. But a central strategy of subduing the COVID-19 coronavirus is to urge people to maintain a safe distance from each other.

Hillsborough County's Rapid Response Recovery (R3) Program takes on this dichotomy. The financial assistance initiative helps businesses pay qualifying expenses not covered by insurance or other assistance programs. Obligations such as mortgages and leases, payroll, utility bills, and vendor invoices that piled up during the pandemic-induced slowdown. It helps businesses survive financially until better days arrive.

Gaston Meredith, president of Gaston's Culinary Services in Ybor City, is among those who applied for and received a grant through the R3 Program. The money, which the caterer will not need to repay, is helping his business cope with fallout from the pandemic. Gaston's outlook is an asset, too: "If you start to worry too much about your problems," he says, "you can't focus on what you need to do to solve them."

Determination, community support, and businesses-model changes all help. A financial boost from Hillsborough County is enabling many small businesses and families, including those in events industries, to cover basic expenses during these unprecedented times.

Since June, the County has allocated \$125 million in financial assistance to small businesses and workforce programs through the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act. With the total business assistance funding limit reached, the application period has closed.

Hillsborough County residents can learn why it's important to support local small businesses, and how to do so, in a series of virtual panel discussions beginning Friday, Nov. 6. The discussions, on successive Fridays, precede Small Business Saturday on Nov. 28.

The facility may be a drinking water treatment plant or a drinking water transmission station, located between Balm Riverview Road and Balm Boyette Road and south of the Balm Boyette Scrub Preserve.

In addition to updating indoor plumbing fixtures and appliances, irrigation systems are a good place to look for quick water savings. Hillsborough County residents may qualify for a free irrigation system evaluation to identify irrigation inefficiencies and get recommendations for a more efficient system.

If the average-sized lawn in the United States is watered for 20 minutes every day for 7 days, it’s like running the shower constantly for 4 days or taking more than 800 showers. That’s equivalent to the amount of water needed for the average family to take one year’s worth of showers.

A household with an automatic landscape irrigation system that isn’t properly maintained and operated can waste up to 25,000 gallons of water annually.
