#### • New Business

- 1. Vince Grizio, acting Treasurer met with Jeanne Cotto, WPOA Secretary, in March per the Waterford Property Owners Association (WPOA) By Laws to discuss any new WPOA projects or homeowner requests for common area maintenance. No projects or maintenance was requested above what is already known.
- 2. The WPOA met on 3 April and requested a 15-20 ft "gray wood" palm to replace a palm tree lost during the hurricane. The Green Team will send an estimate. The WPOA also determined that for this Christmas only the outside Oak Tree and Two Palms will require lighting.
- 3. Additional maintenance identified:
- a. Road to park, bridge, and tennis court light pole bulbs replacement and potential rewiring. Cost TBD.
- b. Road to park easement curb remediation by fallen tree and TECO re-wiring should be covered by the District. Cost TBD.
