

The Spectacular Toledo Swap Meet Vendor Contract

June 28, 2020 and August 23, 2020 Due to the overwhelming success and popularity of the 2020 annual Toledo/ Lincoln County Swap Meets, we will have two more this year on June 28, 2019 and August 23, 2019 from 8:00 a.m. to 3:00 p.m. at Memorial Field, 385 NW A Street in Toledo. Everyone is welcome to sell their wares as long as they are 18 years of age or older.

SWAP MEET CONTRACT

- Toledo Swap Meet Applications are available at the Toledo Chamber of Commerce located at 311 NE 1st Street Toledo, Oregon 97391, by emailing director@toledooregon.org or calling 541-336-3183.
- Space Fees are as follows: Book at least 2 weeks in advance and get the following discount
10' space \$10.00 in advance, \$12.50 day of event.
20' space \$20.00 in advance, \$25.00 day of event
40' space \$40.00 in advance, \$50.00 day of event

ARRIVAL:

- Vendor(s) may set up before the event between 6:00 a.m. and 8:00 a.m. Vendor(s) must unload their vehicles, then move them to a location not interfering with the event. Those vendor(s) that need to leave trailers and/or trucks on the field should notify us in advance so that we can plan for the space. Plenty of parking will be available. Vendor(s) must be ready to sell no later than 8:00 a.m.

DEPARTURE:

- The Swap will close at 3:00 p.m.
NO EARLY BREAKDOWNS OF BOOTHS ARE ALLOWED. EARLY DEPARTURES MUST BE CLEARED BY A MEMBER OF THE SWAP MEET EVENT STAFF. Staff members will be wearing orange t-shirts clearly labeled "EVENT STAFF". In case of an emergency, one of the Swap Meet Staff should be advised. If customers are in the

swap meet area, vendors can choose to remain after 3:00 p.m., but all spaces must be cleared by 4:00 p.m. Vendors must leave the allotted space clean at the end of the day.

MARKET RULES:

- Be considerate of fellow vendors and customers.
- Disrespectful or negative comments will not be tolerated and should be reported to a member of the Event Staff. The Event Staff will request vendors to leave after two warnings of behavior deemed unprofessional.
- Vendor(s) behaving in a manner that may endanger the public or other vendor(s) should be reported immediately to the Event Staff and they will be asked to leave immediately.
- Smoking will be allowed in designated areas.
- **NO DOGS ARE ALLOWED ON THE FIELD.**
- Vendor(s) must be 18 years of age or older.
- Vendor(s) must supervise minor children at all times.
- Failure to conform to such rules and regulations may be grounds for removal from the Swap Meet.
