- ◇ Email was sent out with minutes from April 30, 2025. Greg motioned to accept the minutes , Bob 2nd , passed. Minutes posted to the township website.
- ◇ Rachel: **Treasurer's report** as of May 28, 2025:
 - ✂ Have \$280,002.79 total. Payments were \$7,340.66. There were no large payments. Revenue was \$10,366.71. We did get the delinquent payout. Bob motioned to accept treasurer's report as presented and pay bills. Greg 2nd , roll call, passed.
- ◇ **Public Comment:** Christopher (BPFDP)
 - ✂ 24 runs, 17 medical, 2 structure – 1 Big Prairie, 1 mutual aid, 1 auto fire, 1 downed power line, 2 grass fire- 1 Goodwell, 1 mutual aid. Training was chain saw operation and severe weather training.
 - ✂ The annual pancake breakfast went well, almost 500.
 - ✂ The department has hired Jonathan Shula as Deputy Chief.
 - ✂ There will be some helpers for Clean-up day.
- ◇ Bob: **Zoning report:**
 - ✂ Finished the permit for Rich Van Tuin for an addition to cabin north of Pine Ave.
 - ✂ Working on land division – 1 mile.
 - ✂ Changes in the administration of the County Office have brought about a fee from the County Treasury Department of \$5 per proof of taxes being paid for property being named. This will be paid via a check from the property holder to the County.
- ◇ **Planning report:**
 - ✂ No meeting. Next meeting July 15th.
- ◇ Jennifer: **Clerk's Report**
 - ✂ Audit – Received papers to complete and work from. Tim will work with Jennifer to complete questionnaires which are more detailed than in the past.
 - ✂ Cemetery: There will be one cremation burial June 2nd. Holding off on cemetery ordinance until special project done.
 - ✂ No NCTOA meeting this quarter, but the Clerks will meet at Goodwell June 4th.

 - ✂ Special Project: The Personal Property Tax (PPT) Reimbursement was discussed. The payment has been titled Local Community Stabilization Act (LCSA). So the distribution was not understood since it began for FYE 2016, and incorrectly all was given to the General Fund. It should follow tax distribution claimed on the L-4029. This situation is being resolved to be correctly distributed and to find the correct affect for the current budget, as well as what legally it means for the township.
