

ORDINANCE NO. 83-10 (As Amended August 5, 1987)

ORDINANCE REGULATING TRAFFIC, STREETS AND SIDEWALKS
WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF CHAPIN

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS:

SECTION 1. Attached hereto and incorporated herein is a street map of the
Village of Chapin.

SECTION 2. The street names shall be designated on said street map. Signs
designating street names may be posted at each street intersection as from time to
time and in the manner directed by the Board of Trustees and its President.

SECTION 3. The speed limit throughout the Village of Chapin shall be 25 miles
per hour. Said speed limit shall be posted in an appropriate manner near the junction
of Route 104 and Cooper Street along Cooper Street and near the junction of Route
104 and Ash Street along Ash Street and near the junction of Route 104 and Oak Street
along Oak Street. Said postings shall advise that the speed limit in the Village of
Chapin is 25 miles per hour except as otherwise posted. The penalty for violation of
the speed limit shall be as follows:

- (1) Speed in excess of 25 M.P.H. and less than 41 M.P.H.: First offense shall
be a warning. Second offense a \$50 fine.
- (2) Speed in excess of 40 M.P.H.: \$50 fine.

SECTION 4. Stop signs shall be posted at the junctions of Cooper, Ash and
Oak with Highway 104 such as to require traffic entering onto 104 to stop. A stop
sign shall be posted at the junction of Cooper and Morgan such that traffic entering
into Cooper shall stop. Failure to stop, as posted, shall subject the violator to a \$10.00
fine.

SECTION 5. Traffic on all East-West streets shall yield to traffic on all North-
South streets except at Superior Street where traffic on all North-South streets shall
yield or stop for traffic on Superior as posted. All violators of this provision shall be

subject to a \$10 fine.

SECTION 6. Parking shall be regulated from time to time by the Village Board and posted accordingly. Failure to observe a No Parking posting shall subject the violator to a fine of \$5. No parking areas shall be:

- (1) The West side of Congress for 40 feet North of the junction of Superior and Congress.
- (2) West side of Poplar Street from Superior north to Alley A.

SECTION 7. The Village, upon application approved by the Board, will pay the cost of concrete and delivery thereof for the construction of sidewalks. The property owner shall pay all other expenses including labor. No new sidewalks shall be less than 42 inches wide and 4 inches concrete in depth over except that it shall be 6 inches over driveways and alleys, with a minimum 5 1/2 bag mix. The sidewalks shall also have one-half inch slope to the street with a score every 42 inches.

SECTION 8. The Village will furnish upon application approved by the Board, one 8 foot culvert to enable property owners to construct a driveway across ditches.

SECTION 9. The abandonment of a motor vehicle or other vehicle on any street or way in this municipality is unlawful and subject to the penalties herein set forth. A motor vehicle abandoned on property other than a street or way and in view of the general public is also unlawful except on the property of the owner of said vehicle. If the Village Board determines after investigation that any vehicle is abandoned it shall cause to have affixed to said vehicle a notice stating:

If this vehicle is not removed within 24 hours of _____
(time/date), it may be subject to impoundment.

If, after posting the above notice, any such vehicle is not removed, then the Village shall impound such vehicle and shall attempt to locate the owner thereof. If, after notice to the owner, or diligent attempt to determine and locate said owner, said vehicle is not claimed, it shall be sold.

If said owner is located, he may redeem the vehicle by paying a \$50 storage and removal charge and a \$5 per day storage charge from the date of impoundment to the date of redemption.

SECTION 10. It shall be unlawful to store automobiles or other machinery and implements not in a good, safe, operable condition for a period of 30 days or more within the limits of the Village except in a licensed junk yard. Upon the determination of the Village Board that any such machinery, implements or automobiles not in good, safe, operable condition are being stored in the Village, the Board shall notify the owner of the property on which such items are being stored to remove said items within 30 days of receipt of said notice. If the owner of the property on which said equipment is being stored contests said notice, he may make appeal by giving written notice thereof and said owner shall be heard at the next regular meeting of the Village Board. If, after such notice, appeal (if any) and the lapse of 30 days from the later of the delivery of the notice or the hearing on appeal, said equipment is not removed or removed from public view the owner of the property on which such equipment is stored shall be subject to a fine of \$10 per day for each day the violation continues.

SECTION 11. During any period which the Village Board President determines that a snow emergency exists immediately before, during and after any period of predicted or actual significant snowfall, it shall be unlawful to park along any village street or way during such emergency. Said snow emergency shall not last for any period longer than is necessary for the removal of snow along said streets and ways. Said snow emergency shall be announced in the various local media and posted as appropriate in the Village. The fine for violation of this provision shall be \$20.


SECTION 12. This Ordinance shall be in full force and effect from and after its passage and approval, all as provided by law.

SECTION 13. All traffic signs and directions shall be posted in accordance with the regulations of the State of Illinois.
