

**AMELIA VILLAGE, OHIO**  
**Ordinance O-2014-30**

**AN ORDINANCE APPROVING AND ADOPTING THE 2015 TAX BUDGET FOR AMELIA VILLAGE AND AUTHORIZING THE FISCAL OFFICER TO SUBMIT THE BUDGET TO THE CLERMONT COUNTY AUDITOR AND DECLARING AN EMERGENCY.**

**WHEREAS**, Amelia Village must adopt a tax budget for 2015 and submit the budget to the Clermont County Auditor by July 20, 2014; and

**WHEREAS**, a public hearing to consider the tax budget was advertised and held prior to the adoption of the tax budget;

**NOW, THEREFORE**, be it ordained by Council of Amelia Village, State of Ohio, that:

**SECTION I.** Village Council hereby adopts the budget as set forth in Exhibit A, attached hereto, as the 2015 tax budget for Amelia Village.

**SECTION II.** The Fiscal Officer is authorized and directed to submit the 2015 tax budget to the Auditor by July 20, 2014.

**SECTION III.** Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION IV.** This Ordinance is declared to be an emergency for the preservation of the public health, safety and welfare. The reason for said emergency is the immediate need to approve the tax budget in order to meet the deadlines set forth by Sections 5705.28 and 5705.30 of the Ohio Revised Code. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members of Council, this Ordinance shall become effective immediately upon its passage, otherwise from and after the earliest period allowed by law.

MRS. GERBER moved to suspend the rules requiring three readings on three separate dates.
