Dear Texas-Oklahoma Lt. Governor or Trustee:

Following are general information and instructions for handling Sophomore of the Year applications submitted by Kiwanis Clubs in your division:

1. **The value of this scholarship is \$600.** The Foundation awards 20 scholarships each year. Encourage maximum participation from all your clubs. **REMEMBER** that applicants **do not** have to belong to a Key Club. Receiving this scholarship award has the potential to make a huge difference in a young person's future.
2. Each club may only submit **one (1)** application to you. Some clubs receive applications from more than one high school, but the club is responsible for selecting **one (1)** winner, and sending it to you. That club's winner's application packet **must be postmarked by April 10, 2020. Clubs are instructed to NOT send their nominee's application to the District Office. The Clubs have been informed that nominee applications sent to the District Office will be disqualified.**
3. Select a division winner (either by yourself or a committee). **Please ensure that application is in the requested format.** Mail it along with the Lt. Governor's certification form to the Sophomore of the Year Chair:
