WHEREAS, that the Town of Randolph is applying for financial assistance from the New York State Office of Parks, Recreation and Historic Preservation ("OPRHP") under Environmental Protection Fund Act of 1993 (EPF) and through the Consolidated Funding Application (CFA) for the purpose of funding enhancements at Weeden Park, a municipal park, as well as at the Triangle on Main Street; and

WHEREAS, the enhancements include various improvements to both facilities to address safety concerns and deficiencies, aging equipment and surfaces, provide greater public accessibility, and provide general aesthetic enhancements to a valuable pubic resource; and

WHEEREAS, the bulk of these improvements were previously designed under the Safe Routes to School Project and are ready for implementation and construction; and

WHEREAS, that the Town of Randolph is authorized and directed to accept grant funds in an amount not to exceed \$750,000 for a total project cost of approximately \$2,000,000, as further described in the grant application; and

WHEREAS, that Town of Randolph is authorized and directed to agree to the terms and conditions of the Master Contract developed with OPRHP for such park enhancements at Weeden Park and Triangle on Main Street; and

WHEREAS, that Town of Randolph is authorized and directed to agree to the terms and conditions of any required deed of easement granted to OPRHP that affects title to real property owned by the municipality and improved by the grant funds, which may be a duly recorded public access covenant, conservation easement, and/or preservation covenant; and

WHEREAS, the Town of Randolph fully supports the development and submission of a CFA grant for this public park improvement and intends to provide the necessary local match.
