AN ORDINANCE OF THE VILLAGE OF CHAPIN,
MORGAN COUNTY, ILLINOIS, AUTHORIZING THE SALE
OF A 1988 CHEVROLET PICKUP TRUCK
OWNED BY THE VILLAGE OF CHAPIN, ILLINOIS

WHEREAS, the corporate authorities of the Village of Chapin conclude that it is no longer necessary or useful to or for the best interests of the Village to retain ownership of the following personal property: a 1988 Chevrolet Pickup Truck; and

WHEREAS, the corporate authorities of the Village of Chapin, Illinois, has received sealed bids for the sale of the vehicle and Richard S. Willis submitted the best bid in the amount of \$ 650.00.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the 1988 Chevrolet Pickup Truck, now owned by the Village of Chapin, is no longer necessary or useful to the Village and the best interests of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the corporate authorities accept the bid of Richard S. Willis in the amount of \$ 650.00 and hereby approve the sale of the vehicle to Richard S. Willis. The Village President and Village Clerk are directed and authorized to take all actions necessary to complete the sale of the motor

vehicle. Sale is subject to the prior removal of the snow plow controls and mounting brackets, which the village shall retain ownership of.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
