Budgeting questions:

Savings account being charged \$15 because we are under the required minimum balance.

2/17- Kevin will find out the amount to keep the account free from a fee and move that amount from the checking account.

CD - received \$12 for 6 months. This is not performing as well as it has in the past. Kevin asked if we should close the CD and put money into the savings account or close them both and add the funds to the checking account. Decision was made to leave the account as status quo. Jerome and Kevin will research high yield savings account and other CD's before a decision is made regarding moving funds.

2/17 - Discussion to be continued.

Wetlands:

This is an ongoing issue. President will draft a letter regarding the resident wetland concerns and the park.

Optic fiber:

Board will try and find the sign with the information for the company doing the work. This way we will know who to follow up with if there's damage to property and our lawns are not the way they were before the installation began.

Willie has a link for signs. Board can pick a sign and we can order about 3-4 signs and village will install.
