Festival Rules & Guidelines

- 1. Complete application in full. Food vendors must submit a complete menu with prices which will be approved.
- 2. Application fees will need to be made out to the **Bakersville Community Foundation** & mailed to **PO Box 452 Bakersville NC 28705.**
- 3. Applications will be taken until booth space is filled. Additional vendors will be placed on a waiting list. No more than 3 of the same type of vendors will be accepted (for example soap or candle vendors).
- 4. No applications will be received after May 15th.
- 5. Accepted vendors must check in with the Vendor Coordinator at the check in station before setting up. Due to covid we will be assigning spaces and ensuring adequate space is provided.
- 6. Booth space is 10x10 if you have a larger display you will be required to purchase an additional space.
- 7. Electricity is limited so please specify in the "Special Needs" field, but there will be an additional \$25 fee for the use of electricity.
- 8. Every effort will be made to accommodate a special request for exhibit space, but cannot be guaranteed.
- 9. Parking for craft vendors will be directly behind their assigned space if located past the bridge near the fire department. All other vendors will be able to park in public areas such as behind United Community Bank and Hemlock Drive with the exception of handicapped vendors. **Funeral Home parking lot is to be used for customers only.**
- 10. Food vendors will have assigned spaces.
- 11. Each exhibitor is responsible for collecting and remitting North Carolina sales tax of 7.75% AND as per NC Gen. Stat.66-255, each exhibitor MUST display this document prominently in their tent.
- 12. Cancellation Policy: If you are accepted and then cancel before May 1st your fee will be refunded 50%. AFTER May 1st NO REFUNDS WILL BE ISSUED.

** ALL Food Vendors must apply for and obtain a permit for a Temporary Food Establishment at the Mitchell County Health Department in Ledger, NC. This MUST be done by June1st.

Festival Notes

- ALL vendor tents must be safely secured with a minimum of 10lbs per leg
- Vendors are responsible for their own tent, tables, and display. Someone must be present in the booth at all times and tables should be presentable and have an attractive appearance.
- PARKING IS LIMITED so please plan accordingly for extra vehicles.
- ALL exhibits must present your Business Name on the front of the booth and remain open for attendees until the Festival has completed for the day.
- Alcoholic beverages are not permitted on the grounds. They cannot be served or sold.
- ALL pets must be on a leash no longer than 3 feet and pet owners must clean up after their pets. Citations will be issued if owners do not comply.
- Smoking is only allowed at designated smoking areas.
- All exhibit space must be cleaned up. This includes ALL trash. Failure to clean up your booth space will result in not being accepted to future events.
- You will be notified within 7 days of us receiving your application if you are accepted, and if you are not accepted, your payment will be mailed back to you.

- Generators must be pre approved and only whisper generators are allowed
