All holding tanks must be pumped by owner prior to haul or a fee of \$25.00 will be charged.

Terms and Conditions of Winter Storage ONLY NON TOXIC ANTIFREEZE CAN BE USED FOR

WINTERIZING. Damar does provide waste oil removal, please see office. Please DO NOT use dumpster.

1. Boat hauling must be scheduled at the office. Hauling will be done at yard convenience according to weather and number of boats to be hauled or launched. **BOATS WILL NOT BE LAUNCHED OR HAULED**

SATURDAYS, SUNDAYS OR HOLIDAYS. The yard will, however, attempt to stay close to desired date.

2. BOAT LAUNCHING MUST BE SCHEDULED at the office at haul time as to month and week. Since dock space is limited, boats are allowed a maximum of 7 days dockage, after which, a charge of \$25. a day will be assessed. No boat will be launched without a \$0.00 account balance.

3. Responsibility for DRAIN PLUG REMOVAL AND REPLACEMENT is owner's.

- 4. If engines and fresh water system of heads are to be winterized by the yard, the yard will not be responsible for damage due to freezing if hauling authorization date is after Nov. 1. Holding tanks to be winterized MUST BE EMPTIED BY OWNER before hauling, otherwise a charge of \$150. to empty the holding tank will be made by the yard.
- 5. INSURANCE-The customer shall have his boat adequately insured against loss or damage and shall provide at his cost a policy of public liability insurance. Damar is not responsible for damage or injuries caused by fire, flood, hurricane, theft, wake or any act of God. The customer shall hold Damar harmless in the event of such occurrences. Yard will not be responsible for damage done to WOOD BOATS due to soft wood or structural weakness.

INDEMNITY-The customer agrees to indemnity and save harmless Damar against any and all claims arising out of or traceable to the customer or the customer's boat and/or the failure of the customer to comply with it' obligations created by this agreement. In the event of loss or damage the customer shall acquire no right of action against Damar to any third party subrogate an insurance company to any claims nor permit suit direction or expense of any such insurance company.

6. OUTSIDE LABOR-Outside labor/contractors of any kind are not permitted to work on any boat in storage without the written permission of Damar. Outside labor or contractors will be required to provide proof of

insurance coverage satisfactory to Damar and a \$50.00 fee per day.

7. **INVOICING PROCEDURE**-Invoices for services rendered by Damar for the customer will be sent to the customer upon completion. Invoices will be summarized on a monthly statement. All bills are due and payable within (30) days. A service charge of (1 1/2%) per month (18% annually) will be added to balances past due.

- 8. **DEFAULT-**Any balance which continues beyond (30) days of the statement date shall be considered delinquent. In the event of a delinquent account, the customer hereby grants to Damar a lien upon the boat in storage (land or water), its contents and equipment for any and all charges for service and/or storage associated with the boat or any outstanding accounts the customer has with Damar. This lien shall continue in full force and effect whether possession of the boat is retained by Damar or not. The customer agrees that Damar shall have the right to retain any part of or all of the vessel until all outstanding balances have been satisfied, including attorney fees, etc., expended in efforts to collect any and all balances considered past or overdue. The customer agrees that this agreement shall be binding for any contract with Damar whether written or verbal.
- 9. To minimize possibility of fire, NO ELECTRIC CORDS MAY BE LEFT PLUGGED IN DURING WINTER STORAGE AND NO ELECTRIC HEATERS MAY BE USED.
- 10. NO pressure washing, NO spray painting, NO open flame paint removing and NO sandblasting. NO open fires are permitted in the yard or on the docks at any time.
- 11. Yard will not be responsible for cradles or trailers stored during the summer season. Winter covers and frame work left in yard after June 15 will become property of Damar Ltd. All cradles and trailers must be clearly marked with owner's and boat name.
- 12. Damar Ltd. reserves the right to furnish all materials, equipment and labor for repairs, commissioning & improvements ordered done while stored or berthed at yard.
- 13. Winter storage period ends June 15. Boats not launched by June 30 will be charged 1/2 the winter storage rate, trailered boats storage only at \$20.00 per foot for any part thereafter until September 15.
- 14. If a boat leaks at spring launch, any pumping or checking by yard will be charged at \$120 per hour for labor, \$25. a day for pump rental. If necessary, boat will be hauled at a rate of \$150 plus labor at \$120 per hour.
- 15. YOUR BOAT MUST BE READY TO RUN AT TIME OF LAUNCH. All dock lines (6), fenders and bilge pumps must be on board and operative prior to launching in the spring.
- 16. If boat is not ready to launch within one week of date specified, and becomes necessary to move, it will be done at owner's expense, \$150. plus labor at \$120 per hour.
- 17. Yard has a brokerage office, ONLY YARD "FOR SALE" SIGNS ARE ALLOWED. If your boat is for sale please list it with sales office and we will do what we can to help.
- 18. MARINA TOOLS-The customer shall not use Damar tools, equipment or shop facilities at any time.
- 19. PLEASE HELP US KEEP THE YARD CLEAN. Dispose of all trash in large containers provided. Dogs in yard must be kept on a leash at all times.
- 20. OIL SPILLS ON THE GROUND FROM YOUR BOAT clean up fee \$120 minimum.
- 21. Damar Ltd. reserves the right to charge unpaid balances to the Visa/Master Card # provided below in the event payment is not received prior to launch.
