

# THE COMING JUBILEE WARS

## ACCEPTABLE YEAR OF THE LORD

### *Astronomical and Mathematical Convergences*

The purposes of this study is to exam some nuances of what was, is and will be the Jubilee Year as disclosed in the Bible and how it will be pertinent in the Last Days Jubilee War to come. This study suggests that the proclamation of 'the Acceptable Year of the LORD' was a 2-fold prophetic culmination in which the 2nd part is yet to occur. This study suggests that the 1st part of Jesus' proclamation of the Jubilee Year of Isaiah 61 cannot apply to Jesus' return. The first part, proclaiming 'the Year of Liberty and to set the captives free' and the LORD favor' was fulfilled at Jesus' 1st coming. The 2nd part of the Jubilee Year proclamation, that of 'the Day of GOD's vengeance' is what Jesus is coming back to do. This 'vengeance' of Jesus will fall upon the world, the False Prophet, False Angels, False AntiChrist, and Lucifer himself, etc.

Technically, the 2nd coming of Jesus Christ will fulfill the prophetic 2-fold Jubilee Year proclamation. In essence, the 2nd coming of Jesus will constitute a Jubilee War instead. This study will suggest and present that there is a prior pattern of when the Jubilee Year occurred on Yom Kippur 1966. There was a subsequent liberation event dealing with Jerusalem and the Temple Mount as it was 1 Jubilee Cycle prior in 1918. From 1966, there was also a 7-year correlating pattern that led to the Yom Kippur War of 1973 thereafter. Thus, the stipulation is that based on an applied phi ratio pattern of time since 1966 and the Yom Kippur War of 1973, a coming war will occur on the Jubilee Year war could also be mirrored by a 7-year long cycle of time thereafter. Perhaps the year after will mirror a 7-year timespan could correspond to the 70<sup>th</sup> Week of Years that the Prophet Daniel spoke about or a cycle of a 7-year gap before the Tribulation Period commences. The various timelines do appear to start to convergence in 5776-5778.

The Jewish Civil New Year also corresponds to a partial solar eclipse and is 10 days out from Yom Kippur on which the Jubilee Year is proclaimed and the Kings of Israel were crowned. Nonetheless, if the 7-year pattern from the 6-Day War to the Yom Kippur War is valid and a prophetic template, then perhaps likewise, a 7-year period of time since the last Blood Moon Tetrad series of 2014-15 will correlate to a coming major regional war for Israel. What is the issue? Such a war will coincide with the 3rd factor of Israel's restoration, that of the 3rd Temple. It will be in preparation for the 2nd coming of Jesus, back to planet Earth to execute the 'Vengeance of our God'. Realize that there is yet a serious of major wars that still have to be accounted for. These are mainly the Psalm 83 War, the Gog-Mag War, and the Battle of Armageddon. The coming 'Jubilee War', if based on the prophetic patterns is correct will be the prelude that sets the stage of Daniel's 70<sup>th</sup> Week of Years or 7 years. This constitutes the Tribulation Period, etc.

## **The Golden Ratio Theory**

As with other studies, this study presents the theory that the phi ratio mathematical irrational number can be applied to time in light of Biblical prophecy. This phi ratio occurs throughout all of YHVH's creation from the macro level of the spirals of the galaxies to the spiral so hurricanes and proportion of the human body, etc. It is applied in art and architecture as well. Moreover, the phi ratio is thus suggested to be applicable in the development of time and space itself. Not only is the phi ratio seen in creation but appears to approximate the key and pivotal schedules of YHVH's timeline of prophetic events. This mathematical pattern is seen in eclipse patterns to the very holy Feasts of YHVH. Thus, using this mathematical template of time and progression, perhaps it is a key in helping determine what is still to occur approximately in time, prophetically.

Aside from calculated dates that may or may not be accurate, the patterns of the eclipse cycles and the Feasts of YHVH are calculated, repeatable and thus predictive. It is really then 'scientific' as that is what science is all about, repeatable events based on observable and repeating constants. Now as to the interpretation, that is another issue. The incorporation of the phi ratio onto timelines correlates perfectly to such eclipse cycles and matching Feasts of YHVH. Such a phi ratio prophetic theory is an approximation when the spiral form is used for a more drastic visual effect that stands out. Consider also that such linear timelines are 1 or 2 dimensional from one's end, that is on paper and linear. There are other dimensions that occur, and no doubt are to be understood. For example, in the Bible codes, the codes are on the same 2 dimensional plane of width and height but realize that the very Word, breath of the Creator is written on 2 dimensional paper.

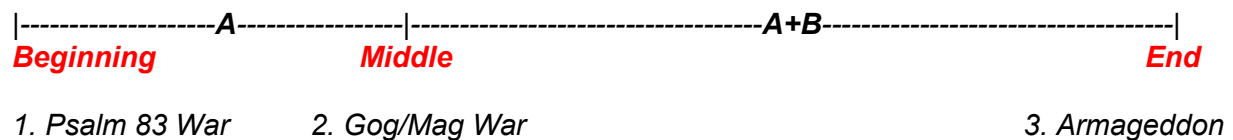
If one had the capacity to go inter-dimensionally, the codes and Word of YHVH could theoretically also go in depth, which one cannot do physically do but computers can model and who knows what codes or meaning could be ascertained. This principle of dimensions is also applicable to the phi ratio theory of prophecy. Why? It is because prophecy is time yet not actualized. Since time is linear, it is predictable and if one had a key or template to ascertain patterns based on concrete cycles that the eclipses and Feasts of YHVH provide as reference points and patterns, then perhaps prophecy could be better understood with such a key. At the focal point of the phi ratio spiral is really a portal or door. If one has seen pictures or diagrams of the phi ratio spiral geometrically 3 dimensionally, it becomes a funnel, a gateway like a spiral staircase or a helix strand like DNA for example.

This study suggests that the same cleavage occurs in time and space and thus becomes a transition point as in a gateway. The case in point is that the Jubilee War to come is in phi ratio to the presumed Jubilee year of 1966 and subsequent Jubilee count and the 1949-1967-2015 Blood Moon Tetrad series. As some researches have pointed out that there are more Blood Moon Tetrads to occur after the one in 2014-15. This study points out that none of the coming ones have this phi ratio 1949-1967-2015 sequence of time markers the event Before-During-After the Tetrads.

## The Jubilee Wars in-between the Tribulation

The question remains, are the Blood Moon Tetrads and apparent Jubilee Year Cycle a 'countdown' since Israel become a nation? This study suggests that a major regional war between Israel and its Muslim enemies is predicted to occur after the apparent Jubilee Year. Why? The supposition is that the pattern corresponded to the liberation of the Temple Mount in 1967. This study holds to the opinion that this coming Jubilee War will likewise be related to a Temple Mount event or become as a result of it. This study suggests that the prophetic pattern will involve a Jubilee War that is further divided into a 2-fold fulfillment. It will be the Tribulation Period itself that will be bookended by this 2-fold Jubilee War. It will be a Jubilee War once at the beginning of the Tribulation Period that could initiate in some way or form the last week of Daniel's prophecy and one at its end with the literal and physical return of Jesus Christ.

### *Possible Tribulation Period War Pattern*



This 2-fold Jubilee War to come comprises the 'gap' of time in-between the judgments of Israel to fulfill Daniel's 70<sup>th</sup> Week. The culmination of the ultimate Jubilee War will occur at Jesus' return across from the Temple Mount. This final Jubilee War, aka the War of Armageddon will coincide with the culmination of the Seal judgments. An argument can be made that when Jesus returns, He will be 'proclaiming liberty and setting the captives free' as it pertains to Israel perhaps. This notion could apply but the initial Jubilee Year judgment and release was pertinent to sin and the eternal damnation of all mankind, not just a political and/or social liberation based on military oppression of Israel. The Church Age has been the parenthetical dispensation between Jesus' 'Jubilee Proclamation' made in the synagogue of Nazareth. The rationale is that in one prophetic aspect, the Jubilee Year is interrelated or synced with a 3-fold actualization based on the Blood Moon Tetrad series of 1949-1967-2014.

At each occurrence, it approximated an extreme prophetic significance concerning the Jewish people. As other studies have suggested, such Tetrads are in tandem with the sequential restoration of Israel that this study suggest could have started the prophetic countdown to the 2nd coming of Jesus and the culmination of the final Jubilee War. The 1st actualization of the countdown sequence started with the UN Proclamation of a 2-State Solution in 1947 that the Muslims rejected. Then there was the Declaration of Independence and birth of the State of Israel in 1948 and the UN recognition of Israel as a member state in 1949. The 2nd actualization occurred on a presumed Jubilee Year, 1967 that saw the ancient city of Jerusalem along with the Temple Mount liberated from the Muslims. The 3rd actualization is yet to prophetically occur, with is the supposition of this study. Based on the Before-During-After patterns, it will be after the completion of the Tetrad of 2015. This study suggests that the next regional war between Israel will rather be with the various Muslims Jihadist coalitions instead of a regular national army.

## **The Fig Tree Generation**

The point is that if and when this coming war occurs, it will coincide with a Jubilee Year count of time and thus a 'Jubilee War'. This war could be the catalyst for the 3rd actualization that could see the 3rd Temple come as a result of a spoil of war or a political and religious compromise. Another prophetic aspect of the 3-fold actualization of the countdown is that the Tetrad and its associated event of Israel becoming a nation and the capture of the Temple Mount are in approximate phi ratio of time. This mathematical phi ratio has a Jubilee Year count within its timeframe from 1967 to 2017 of exactly 50 years. Is this mere coincidence? The Yom Kippur War in 1973 has a Jubilee Year pattern of 50 years that occurs in 2023. This study also suggests that the coming World War 3 could actually be one in the same, the Jubilee War between the Muslim paramilitary coalition of various factions and Israel.

The point being is that the 2 prior prophetic time markers of 1949 and 1967 were enveloped in major war for the survival concerning the Jewish people in the land. Thus, if the patterns of the prior 2 Tetrads and their respective mathematical time ratios are any possible indication of what is to come at this Jubilee Year juncture in time. Perhaps then, the 3rd juncture could altogether not be related to Israel but the Church Age. Many would dismiss such theories and scenarios, as the actual count of the Jubilee Year has been so called 'lost'. However, the patterns since 1917, a prior Jubilee Cycle saw a prelude to the liberation of Jerusalem and the Temple Mount to come in progressive and prophetic fulfillment. Some prior Biblical studies have speculated that the event of Israel becoming a state in 1948 signaled the 'countdown' to the 'Last Generation', the Fig Tree Generation even.

Thus, the re-capturing of the Temple Mount was what many speculate was the start of the 'Last Jubilee' (50th) before Jesus returns. It echoes the Pentecost or how the Church Age has been the center 'parenthetical dispensation'. Until that time is concluded, Israel is being constantly told to return to its pre-1967 borders if not the 1948 one as a condition for 'peace' as a condition for the establishment of the new Palestinian State by a decree of the Quartet US, EU, UN, and Russia. What makes this condition suicidal for Israel is that it would make its borders defenseless geographically; at one-point Israel's territory would only be 8 miles wide. This will give incentives for a Muslim-league of nations to most likely attack Israel at a future convenient time.

What most would not realize, if not for Biblical scholarship and prophecy students to note, is that such a condition would also render the Old City, and particularly the Temple Mount back to full Arab control. In the 6-Day War of 1967, the Temple Mount was recaptured by Israel, 1897 years after the prophesied destruction spoken by Jesus in the Olivet Discourse at the hands of Titus, the Roman Prince in AD 70. In a twist of politics, Moshe Dayan as an appeasement then gave over the Temple Mount to Muslim Administration. The world and the Muslims are demanding a Palestinian State. It would have East Jerusalem's Muslim Quarter as the capital but the Dome of Rock. At no point in history has such a people held all these institutions.

The Temple Mount complex will not be divided to not allow for a Jewish 3rd Temple as part of a Treaty that is coming to be rebuilt. If the supposition is that when Jesus came and presented Himself to Israel, it was not Israel that was to test Jesus as the religious leaders of Israel did constantly but it was Israel's King that was to test the fruit of His Earthly nation. Even so, Jesus alluded to this by the cursing the Fig Tree literally and the parables of the Husbandrymen that came to visit for a harvest but instead the evil tenants killed the 'Son', the heir. So too have now the evil Luciferian stewards been trying to possess the inheritance, this includes the eternal heavenly one as well. As Israel had no 'fruit', it became cursed of the LORD, the land, and its Royal Commission given to another, the Church.

This is not Replacement Theology as some teach but Israel has been set aside until the time of the Gentiles are fulfilled and come into the Commonwealth of Israel. Realize that with the type of the Fig Tree Jesus sought to acquire fruit but there was none, and He cursed it. The cursing of the Fig Tree literally and the parables of the Husbandrymen were fulfilled as Israel went into exile and the Church took on the Royal Commission of preaching the Gospel of salvation and the Kingdom to come to all the Nations. If the start of Jesus' ministry was in fact the start of the prophetic countdown of a 40-year 'testing' that the number implies as was for Israel with Moses in the Wilderness, then 40 years minus 70 AD is when the judgment fell upon Israel.

It is around the year 29-30 that in fact could be the time frame when Jesus started His public ministry at the point of His baptism by John the Baptist. This is assuming 32 AD was the crucifixion year. If so, then some amazing calculations occur. This could also mean that if the pattern is to repeat at the End of Days in similar fashion, given the timeline of 2023, then 40 years minus the year 2022 is 1984, excluding end year. Astonishingly, this is the same amount of years that if once take from the year 32 AD and one adds the years that the midnight Blood Moon occurred on April 14, 32 AD. This has a direct correlation to the start of the Tetrad of 2014-15 on the same day, April 14, 2014, it equals exactly 1982 years. Is this coincidence?

Would this strengthen the argument for the 2023 window of when the Tribulation Period is to perhaps start? The context is thus also that the Church Age has been a 'prophetic' 40-year countdown and her time of testing is up, perhaps as the Tetrad, Jubilee Year Cycle, and Sabbath Cycle converge in such a prophetic season. Others however believe the Jubilee Year is unknowable and incalculable. In addition, it does depend on what Jewish Calendar one is using. This study suggests that the series of this cluster of 3 Tetrads correlate to the prophetic restoration signs of the countdown to the AntiChrist, the Tribulation Period, and the Rapture of the Bride of Christ. Thus, this study suggests that the next point of prophetic fulfilment will be the construction of the 3rd Temple that will also unfortunately involve another Jubilee Year War. What the astronomical and mathematical patterns suggest is that the 3-fold prophetic template is indeed occurring in direct relationship to the Blood Moon Tetrads and the phi ratio of time spacing. This would then allow for the 'testing' to commence for Israel that is the Time of Jacob's Troubles or 'Great Tribulation'.

## **The Jubilee City**

There again, there could be a respite or gap in-between the Rapture and the 'Confirming of the Covenant' between Israel and the 'Many'. If in fact the lost count of the Jubilees Years does synchronize with 1917 and 1967, then the Jubilee Year after the liberation of the Temple Mount, which will be the first since Israel took back the land, did coincide with 2017. This would make the Jewish year of 5777. Unfortunately, those prior times were marred by war, a major war offensive that involved Israel, its Muslim enemies, and the West. This study suggests that if the prophetic patterns are valid and reliable, the subsequent time of the Jubilee Year timeframe will likewise see a repeat of the 6-Day War, another Jubilee War. This will not involve a limited war offensive, as there has been numerous over the decades against Muslim insurgents.

The nature of this coming Jubilee War will comprise a level of attack, conflict and/or war that will escalate at the national level as it was during the 6-Day War that involved regular army units of various Muslim nations. As it is now, the paramilitary organizations of Hamas, Hezbollah and ISIS are being funded by nation states. Iran, Arabia, the EU, US and Russia are directly involved in various levels. What this coming Jubilee War could amount to is an all-out assault of Israel from all fronts as it was in 1948, and 1967. This is the difference since 1967 that the subsequent limited 'wars' were not at the level of nation states. In fact, some historians actually see the 6-Day War as a proxy war between the US and the then USSR as the Cold War had dictated such involvement in the 3rd World.

By some calculations, the liberation of the Temple Mount by Israel occurred in the season of Pentecost, a 50-day count from the Passover Blood Moon of April 24, 1967. This 50th day or the 120th day was June 13, 1967. Some have calculated based on a 360-year calendar that Pentecost was on June 5, 1967. This was really a '9-Day War' as the brunt of the fight was determined from June 4<sup>th</sup>, eve to the 10th. It was on the 7th of June or the 3<sup>rd</sup> day that the IDF reached the Temple Mount and raised the Israeli flag. It was Chaplain Shlomo Goren that blew the shofar at the Western Wall. This day was the first since the destruction of the 2nd Temple in 70 AD that Jews were even allowed on the Temple Mount platform. Since that time, the Jews experience the 2nd Diaspora that took them to the 4 corners of the world.

This was foretold by Jesus in the Olivet Discourse. The prophetic progression of judgment would be reversed that first start with Israel becoming a nation. Then the Temple Mount and it will end with the 3rd Temple. This is the unique code that was given by Jesus to His Disciples as they overlooked the Temple Mount across the Kidron Valley from the Mount of Olives, not the City of David. Interestingly, he was born in 1917, the 50th year prior when Jerusalem was liberated by the British under the command of Allenby. The surrender of the Ottoman Turks to Allenby occurred on the 11th of December, the first day of Hanukkah. This ended the 400 years of Turkish rule. In his famous gesture of reverence for the Old City, Allenby entered through the western Jaffa Gate on foot. This was also mirrored by the entrance on foot from the Lion's Gate by the 3 major leaders of the 6-Day War, Dayan, Rabin and Uzinarkis.

Chaplain Shlomo Goren proclaimed the following statement from the Western Wall. 'I am speaking to you from the plaza of the Western Wall, the remnant of our Holy Temple. 'Comfort my people, comfort them, says the LORD your GOD.' This is the day we have hoped for, let us rejoice and be glad in His salvation. The vision of all generations is being realized before our eyes: The city of GOD, the site of the Temple, the Temple Mount and the Western Wall, the symbol of the nation's redemption, have been redeemed today by you, heroes of the Israel Defense Forces. By doing so you have fulfilled the oath of generations, 'If I forget thee, O Jerusalem, may my right hand forget its cunning.' Indeed, we have not forgotten you, Jerusalem, our holy city, our glory. In the name of the entire Jewish people in Israel and the Diaspora, I hereby recite with supreme joy, Blessed art Thou, O LORD our GOD, King of the Universe, who has kept us in life, who has preserved us, and enabled us to reach this day. This year in Jerusalem – rebuilt! ' –General Shlomo Goren, Chaplain of the Israeli Defense Forces

Since 1917, under the Muslim 'benevolent and peaceful rule', Christians were not allowed to worship in the Church of the Holy Sepulcher and Jews were not allowed to touch the stones of the Western Wall. After the 6 Day War, for the first time in Jerusalem's history the legislative body of Israel, the Knesset passed resolutions to protect all religious locations in Old Jerusalem and protect the religious freedom of its citizens. This was something that was not implemented under the centuries of Muslim oppression. On the contrary, the official Islamic policy was forced assimilation, persecution and/or death. It also 'proclaimed' in 1969 to 'restore' the Walls of Jerusalem and the Jewish Quarter. It was Jesus Christ who laid out the prophetic blueprint of how the 3-fold judgment were to occur precisely in the Last Days.

This judgment of the Temple, City and Nation started as it did in the days of Ezekiel with the Glory of the LORD departing the Temple first, then from the City and then from the Nation in 70 AD. An aside note. This is another proof that the false claims that the Temples were down below in the City of David is not true. The Glory of YHVH departed directly in line with the Mount of Olives before it went up to Heaven. In fact, it will be the same trajectory that Jesus will come to the Mount of Olives at His 2nd coming. With this prophetic template, this is what exactly has been occurring after the crucifixion, death, resurrection, and rapture of Jesus but in reversed order since the rebirth of Israel in 1948. Based on Christian interpretation of the rejection of Jesus as the true Messiah of Israel, the judgment of YHVH fell on Israel. The God of Israel used the Romans to execute this grim judgment for a 3rd time in the Israel's history. The nation was already occupied by the Romans. It was also on the 9th of Av, in August of 70 AD that the Romans breached the Old City from 4 sides. The 2nd Temple was leveled, then the City was destroyed, and the Jewish Nation was exiled.

## **The Prophetic Codes of Restoration**

The key to the sequential restoration is the Jubilee Year Cycle pattern that would likewise occur not in the same order and in reverse but subject to the phi ratio mathematical progression of time and space. The budding of the Fig Tree, that of Israel metaphorically would be the time in the Last Days that the generation that would witness this and will see the return of Jesus. The 6-Day War that secured the Old City that comprised of the Temple Mount was the 2nd of the 3-fold 'prophetic keys' of restoration for Israel. This study suggests that the last piece of the prophetic puzzle and template given by Jesus will thus be the reconstruction of the 3rd Temple at the possible convergence of a set time just after the last Tetrad sequence and the last Jubilee Year Cycle before Jesus returns.

This supposition follows the prophetic pattern of the Tetrads and Jubilees. What is also supporting this assertion that has to do with the Blood Moons and the phi ratio pattern of time is suggested template of sequential restoration given by Jesus at the Olivet Discourse. These are 3 main events, the rebirth of the Nation, the securing of the Temple Mount and the rebuilding of the 3rd Temple that are necessary or are prophetic pre-requisites before Jesus can return. It will be as in the days of Rome, just when He had 1st visited Earth. By some estimates, the birth of the Israel in 1948 is what has started this prophetic clock countdown to the final week of Daniel's prophecy. Israel's rebirth, although not in faith is nonetheless was the 1st of the 3-fold 'prophetic keys' of the prophecy of the promise of restoration by the 'Master Potter', Israel's Messiah, Yeshua of Nazareth. He is the LORD of the Sabbath, the LORD of the Jubilee, He holds eternal life, liberty, and freedom; foremost freedom from sin and eternal death.

This condition is available, free of charge for any person because of Jesus' exchange at the Cross of Calvary made it possible. After all, that was Jesus' mission to accomplish at His 1<sup>st</sup> Advent; to revive and rectified Humanity's destiny. The Bible states that Humanity is in a state of war in league with Lucifer against its Creator. Jesus came to make peace by His blood. This 'Peace Treaty' between Mankind and YHVH was confirmed on a Jubilee Year in Israel, in Jerusalem, outside the Temple Mount that He Himself liberated, is liberating and will liberate. Why? It is because Jerusalem is 'the City of the Great King'. The Temple Mount is where His Earthly House is at. The risen King of Glory is inviting Humanity not to be part of this continuing war that will culminate in Him executing 'the Vengeance of our God', etc. Surrender and be part of His Kingdom, His Nation, and His Holy City.
