Munyan Construction continues with the phased worked for waterproofing of the walkways for the Towers and Villa 9.

Due to the prep time & product installation cure time requirements, Munyan is asking residents to vacate their units during the time frame indicated below for the completion time for their building. 
LOG into ZOOM APP > Download **Zoom** to your Computer, iPhone, iPad or Tablet:
