### **Public Hearing Minutes – New Connection Rate Increase**

**December 11, 2025 – 6:00 PM**

**FSSD Office – 6185 S 45000 West, Fruitland, Utah**

#### **1. Call to Order**

Chair Vicki Savage called the public hearing to order at **6:03 PM** and stated that the hearing was being recorded in compliance with the Utah Open and Public Meetings Act (OPMA).

#### **2. Roll Call**

##### **Board Members Present**

- **Vicki Savage**, Chair
- **Mike Wilkerson**, Trustee
- **Michael Scheetz**, Trustee

##### **Staff Present**

- **Judy Wilkerson**, Clerk / Administrative Director

A quorum was present.

#### **3. Purpose of the Public Hearing**

Chair Savage explained that the purpose of the hearing was to receive public comment regarding the District's proposal to adopt **new connection rates**, as required by Utah law.

The proposed **Total New Connection Cost** is **\$21,300**, consisting of:

- **Water Connection Fee: \$12,000**
- **Impact Fee: \$4,000**
- **Meter, MXC, and Installation Costs: \$5,300**

The increase reflects updated water, material costs, labor requirements, contractors' pricing, and associated infrastructure needs necessary to maintain safe and reliable service.

#### **4. Public Comment**

Chair Savage opened the floor for public comment.

**No members of the public were present, and no written comments were received before the hearing.**

After allowing adequate time for comment, Chair Savage closed the comment period.

#### **5. Board Discussion**

The Board briefly discussed the updated rates and noted that:

- Costs for materials and excavation have increased significantly.
- The new rate ensures the District does not subsidize individual new connections.
- The proposed total of **\$21,300** is necessary to protect the District's financial stability.

No further questions or concerns were raised.

## **6. Motion to Adopt the New Connection Rates**

### **Motion**

Trustee **Mike Wilkerson** moved to adopt the **new connection rate of \$21,300**, consisting of:

- \$12,000 Water Fee
- \$4,000 Impact Fee
- \$5,300 Meter, MXC, and Installation Costs

**Second:** Trustee **Michael Scheetz**

- **Wilkerson – Yes**

**Motion passed unanimously.**


## **7. Adjournment**
