THERE ARE FOUR DISTRIBUTION DAYS PER MONTH. HISTORICALLY, THESE HAVE BEEN PICK-UP DAYS. WITH THE EMERGENCE OF COVID-19, DISTRIBUTION CHANGED TO THE DELIVERY OF PRE-PACKAGED BAGS TO EACH SHOPPER'S ADDRESS. IN FEBRUARY 2020 THERE WERE FORTY-THREE SHOPPERS AND BY JUNE THE VOLUME HAD INCREASED BY 140% TO ONE HUNDRED AND SIX SHOPPERS.

THE FOOD SHELF CONTINUES TO WORK WITH THE LOCAL SCHOOL DISTRICT (CVSDVT) THROUGH OUR "FOOD THAT'S IN WHEN SCHOOL IS OUT" PROGRAM WHICH TYPICALLY SERVES BETWEEN THIRTY-FIVE AND FIFTY CHILDREN. DURING THE PANDEMIC THE SCHOOL DISTRICT CONTINUED TO PROVIDE PICK-UP LUNCHESES. IN
