AN ORDINANCE AMENDING ORDINANCE NO. 2009-3, AS PREVIOUSLY AMENDED, ENTITLED AN ORDINANCE ESTABLISHING AN INCENTIVE COMPENSATION POLICY FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS

WHEREAS, on February 11, 2009, the corporate authorities of the Village of Chapin adopted Ordinance No. 2009-3 entitled *An Ordinance Establishing an Incentive Compensation Policy for the Village of Chapin, Morgan County, Illinois*;

WHEREAS, on January 11, 2017, the corporate authorities of the Village of Chapin amended Ordinance No. 2009-3 by the adoption of Ordinance No. 2017-1; and

WHEREAS, the corporate authorities of the Village of Chapin have determined that it is in the best interest of the Village to amend Ordinance No. 2009-3, as previously amended, to change the eligibility requirement for incentive compensation.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois as follows:

Section 1: Section 1 of Ordinance 2009-3, as previously amended, is repealed and replaced with the following new Section1:

Section 1: For purposes of this Ordinance, the term *eligible employee* shall mean a full-time or part-time employee who has been an employee of the Village for at least one (1) year. An *eligible employee* also includes an employee whose term of service to the Village is about to end or has recently ended, but has prior to the end of the term been an employee of the Village for at least one (1) year.

Section 2: This Ordinance shall be in full force and effect upon its passage and approval as provided by law.
