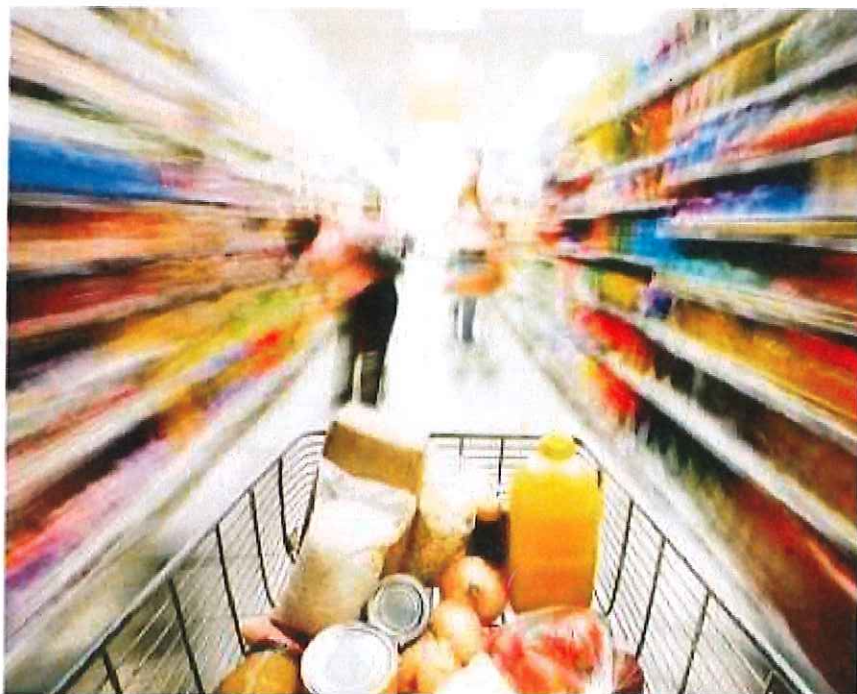


# Garnett Grocery Grab

GROCERY GRAB CONTEST RULES

1. Provider cannot be held responsible for any winner's ability to successfully complete an entry. Winner is subject to qualifications with these rules and regulations.
2. Winner(s) will be determined by random drawing by the Garnett Community Foundation Board.
3. Country Mart, 425 North Maple, Garnett, Kansas is the designated location for the Grocery Grab.
4. The winner, at the designated time, will have four (4) minutes to grab as many groceries as possible up to a dollar value of \$750. The groceries must fit in or on one grocery cart without any aid from anyone other than the winner. The grocery cart will be designated by the Garnett Community Foundation Board. Modifications, alterations or additions to the grocery cart for the purpose of increasing its capacity are not permitted. The starting location will be designated. Once the time has elapsed, the winner must push the grocery cart to a designated checkout lane. Any groceries that fall off the grocery cart are disqualified. All grocery items must go through checkout. No substitution can be made for an item that has gone through the checkout register. Winner will keep all groceries that are eligible.

Second place will be a \$100 grocery gift certificate and there will be one (1) \$50 grocery gift certificates awarded.

5. Only grocery (i.e. food) items are permitted. Specifically, alcoholic beverages, deli counter items, personal care, pharmaceutical, magazines, books, DVS, over-the-counter medications, are prohibited. The Garnett Community Foundation Board reserves the right to prohibit other items whether announced or not.
6. Winner(s) will be required to sign a release form prior to participation. The Garnett Community Foundation Board will determine, in its sole discretion, winner's compliance with eligibility requirements, and compliance to contest rules. Any questions or disputes will be handled exclusively by the Garnett Community Foundation Board. All decisions are final.
7. The contest is open to all persons **EXCLUDING** members of the Garnett Community Foundation Board or those immediate family members living in their home.
