Entries need to be postmarked by June 8th to be in the pre-draw

- 1. NO DOGS allowed in the indoor arena.
- 2. Horse must be named on entry form. Please enter with horse's registered name. •
- 3. Horse and rider must run in order drawn or be disqualified. There is no charge for a horse change in the 5D Open for horses that are not already included in the draw. Please see the office before 9:00 am day of the race.
- 4. 15/40 5D Race -for any rider 15 and under and 40 or older as of Jan 1st 202016/39 is for racers between 16 and 39 years of age.
- 5. Open 5D will be ½ second split and will run after the Futurity. 70% payout & 100% of added money will be jackpotted.
- 6. **Derby horses** must be 7 years and younger as long as they did not compete in futurities as a 4 year old. There are 2 years of Derby eligibility, 5 and 6 year olds (if competed in futurity as a 4 year old) OR 6 and 7 year olds if competed on as a 5 year old
- 7. ALL HORSES ARE REQUIRED TO BE IN THE HOLDING PEN "NO EXCEPTIONS" If you are not in the holding pen when your name is called you will be DQ.
- 8. \$5 -cash hat fine (mandatory to get hats back). When hats are lost in the arena it uses up time plus it is a REAL safety issue for barrel setters
- 9. Dress code required Sat. & Sun. Open and Futurity long sleeve shirt (collar not req.), long pants, western boots, western hat or helmet. FRIDAY NO WESTERN ATTIRE
- 10. There will be separate draws done for the late entries. Late entries will run at the end both Saturday and Sunday.
- 11. 5D Go Round Awards, 15/40 & 16/39. Must be present for awards or have a designated person pick up your award. Let office know who will pick up award ahead of time.
- 12. IFA Target Saddle Presentation Target Saddle Winner must be present to receive saddle or we will drop down to the next person
- 13. Xtreme Barrel Club -Co Sanctioned must be a member of Xtreme Racing Club before you run. \$3 fee per Open Race per horse -pay before you run.
- 14. WPRA: Rider must be WPRA member to enter WPRA Side-pots and can enter one time/one horse.
- 15. Vet or Sick Out-70% of entry will be returned when Vet/Dr. release is received after the draw is completed and posted. No vet outs after the race has begun.
