AN ORDINANCE OF THE TOWN OF PIERSON, FLORIDA, AMENDING THE TOWN OF PIERSON UNIFIED LAND DEVELOPMENT REGULATIONS, ARTICLE II, SECTION 2.2, DEFINITIONS, BY ADDING CEMETERIES AS A SPECIAL EXCEPTION IN ALL ZONING CLASSIFICATIONS EXCEPT THE C, CONSERVATION AND ELD, ENVIRONMENTALLY LIMITED DEVELOPMENT AREA CLASSIFICATIONS. PROVIDING FOR SEVERABILITY; REPEALING ALL LAWS OR PARTS OF LAWS IN CONFLICT HERewith; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.
