I attended the workshop, not with the intention of doing a project but to learn, and learn I did! What I found most fascinating was the pie chart of the sources of phosphorus for The Briggs Lake Chain. What the sources were and their percentages was very interesting, the numbers were not what I expected. Also, they pointed out some lakes have a small watershed area making for cleaner lakes. Our chain has a huge watershed area making for a larger phosphorus load and poorer water quality. These were just a few of the things I learned. Was the meeting boring, no. Was it exciting, no. Was it was worth my time to go, yes.

This summer consider attending the BLCA meetings. It's not mandatory nor required like school, but once you go you'll be glad you did. The first meeting on Saturday June 9th will include a band concert and a lunch. The July 14th meeting will be to present the information from the Fly-over testing that we did last year, explain what will be happening and answer your questions. There seems to be a lot of misinformation about the fly-over going around, so attend, be informed and educated on what the results are and what the next steps are going to be. You'll be glad you did.

SERP and Healthy Lakes Mini-Grant Workshop Held on April 21, 2012

Briggs Lake Chain Members were very pleased to hear the basics of Lakeshore restoration and lessons from previous projects by Mark Basiletti on Saturday April 21, 2012. Mark presented basic information on how shoreland restoration projects are helpful in restoring the lakeshore with buffer strips, rain gardens, and to stop runoff of harmful nutrients. All of these activities are necessary for us to achieve the goal of getting our lakes (Big Elk, Briggs, Rush, and Julia) off of the Minnesota "impaired waters" list.

Ken Gossett (BLCA Vice President) presented information on the \$25,000 DNR grant monies available through the BLCA. Grants of up to \$2500.00 can be awarded to families who desire to participate in the Lakeshore Restoration Project along with an additional \$500.00 from a BLCA Mini Grant. These projects need to be planned, implemented, and completed prior to June 30, 2012. If the monies are not spent, they would be lost or transferred over to other projects that are more active. With the uncertainly about funding after July 1, 2012, the BLCA is ready to assist homeowners with their shoreland projects now. Kenzie Phelps has stated "It took years of neglect for our lakes to become impaired, and it will take years to undo the damage. But what we do now is our legacy for the next generation, and we are trying to make it a positive one."

Please give Ken a call at 320-743-6896 if you are interested in getting started and doing your part to help get our lakes off the impaired lakes list!
