MINUTES OF THE CLOSED MEETING OF THE LYONS TOWNSHIP TRUSTEES OF SCHOOLS March 16, 2016

1. Call to Order.

The Closed Session of the Lyons Township Trustees of Schools was called to order by President Michael Thiessen at the Township School Treasurer's Office, 22 Calendar Court, LaGrange, Illinois at 7:51 p.m.

2. Roll Call.

Taken by President Thiessen. Present were President Thiessen, Trustee Tobolski, Trustee Dickman, Treasurer Susan Birkenmaier, attorney Kurt S. Asprooth.

3. Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when a public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 120/2(c)(5).

The Board discussed the recent court hearings on the litigation against School District 204, and the delay by School District 204 in submitting mediators as the Judge directed.

4. Discussion of the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body. 5 ILCS 120/2(c)(5).

Treasurer Birkenmaier discussed the fact that Fran Green approached her to discuss a potential separation agreement whereby the Trustees would pay for her health insurance in exchange for a release of all claims. Trustee Birkenmaier discussed the potential terms of an agreement, and also whether any of the other employees would be interested in a similar separation agreement. The Board then discussed the financial impact of entering into separation agreements. The Board discussed the likelihood that Donna Lewis and Beverly Carnevale would also approach the Treasurer about a separation agreement that included continued health care coverage. The Board discussed the amount of money that they would be willing to agree to pay to the three employees in continuing healthcare coverage. The Board then discussed the performance of Beverly Carnevale, Fran Green, and Donna Lewis. The Board also discussed which specific employees of the office would take over Beverly Carnevale, Fran Green, and Donna Lewis's job duties if they do enter into separation agreements.

The Board then discussed the performance of specific employees, and specifically the potential increase in Mike Vargas's salary. The Board decided to revisit the issue in advance of the July 1, 2016 salary updates.

The Board then held an additional discussion on the performance of Beverly Carnevale. The Board also revisited the issue of how much they would be willing to offer in continuing health care coverage for separation agreements with Carnevale, Lewis, and Green.

The Board then discussed the overpayments made to Carnevale for her IMRF employee contribution. The Board discussed the possibility of including the IMRF overpayment as part of a potential separation agreement with Carnevale.

The Board again discussed how the potential separation agreements with Green, Lewis, and Carnevale would be structured, and how much they would be willing to offer. A discussion was then held on the accrued vacation that Carnevale, Green, and Lewis currently have and the financial impact of paying out the accrued vacation days in conjunction with a separation agreement. The Board discussed the timeframe for negotiating and approving the potential separation agreements.

The Board again discussed the resolution of the IMRF overpayments to Carnevale and Lauralee Conway, and how a settlement agreement with Lauralee would be structured. The Board also discussed how a settlement agreement with Carnevale would be structured, the amount of the total overpayments, and the potential inclusion of the IMRF overpayments as part of the consideration of the potential separation agreement with Carnevale.

5. Adjournment.
