

STWEC Staff Message

Thank you for being a member of Shasta Tehama Watershed Education Coalition (STWEC). STWEC's primary goal is to help members comply at the lowest possible cost with the Irrigated Lands Regulatory Program (ILRP) mandated by California's State Water Resources Control Board (SWRCB). The alternatives to STWEC membership - either an individual wastewater discharge permit or a non-compliance fine levied by SWRCB - are more expensive. An important secondary goal is providing education to our members and relaying reliable data to SWRCB to confirm that our members are responsible stewards of land and water systems.

Our board of directors (Sam Mudd, Martin Spannaus, James Lefor, Ron Keown and Glenn Hawes) approved our annual budget and were able to lower the cost to the members! Our 2024 membership fee is \$150.00 and \$2.75 per irrigated acre.

SECP Self-Certification Portal <u>OPEN</u> for the Month of February <u>ONLY</u>

The Sediment and Erosion Control Plan (SECP) Grower Self-Certification Training will be

available from February 1, 2024 to February 29, 2024.

The Training Portal is designed for growers who are required to prepare a certified SECP as part of their membership in the Irrigated Lands Regulatory Program. If you are required to prepare an SECP. Becoming self-certified is one option.
