- 2. Election of officers was conducted by secret ballot and were counted by Pat Cieskiewicz and Carl Olson Elected to the Board of Directors for a 3 year term were Melissa Harris, Bob Heal and Joanne Duga.
- 3. Vote by signed ballot was held for 2 amendments to the Wexford West HOA Documents. A yes vote of 2/3 (124) of the WW members was needed to pass. Ballots were counted by secretary Gayle Lawrence and HOA member Dianne Luttman. Proposed Amendment 1 was removing the 3% cap maximum for the annual budget 37 yes votes did not pass. Amendment 2 was property ownership for a minimum of 2 years before an owner could rent it, board approval for prospective tenants and background checks 61 yes votes did not pass.
