Pasta on the Prairie Made in Amana

A Marion, Iowa based pasta company was purchased in December by the Amana Society, Inc. Operations will be in Homestead at the Amana Farms Beef building located at the intersection of Highways 6 and 151.

Jeff Popenhagen, ASI chief revenue officer, announced that Pasta of the Prairie makers of hand-crafted pasta specializing in pasta-based food kits and marketed primarily at farmer's markets and on-line was purchased by ASI.

Founded in 2014 by Lindsey and Tyler Steinkamp in Marion, the company started as a creative outlet as they made their own delicious pasta. They make a line of 20 products including meal kits for pasta salad, white cheddar soup and pasta meals sold at farmer's markets and via their website. Their hallmark is that their meals are easy to prepare and feature their own pasta. Pasta meal kits retail for about \$10 and feed three to four people.

"Purchased in December 2025 by the Amana Society, Pasta of the Prairie continues today through Amana Farms Foods. Honoring Tyler & Lindsey's original vision, we are carrying forward the same hands-on mindset. As part of the Amana Food family, Pasta of the Prairie expands a heritage driven food tradition dating back to 1855. Adding pasta production in Homestead builds a more complete food experience, pairing thoughtfully made pasta meal kits and comfort foods with the craftsmanship that defines all Amana products," Popenhagen said.

Amana will make and sell pasta under both the Amana and the Pasta of the Prairie labels. ASI will diversify the sales approach selling in Amana retail stores, at a few select, larger farmer's markets, on the Amana Shops website and in the Amana Meat Shop and Smokehouse catalog.

Additionally, a line of private label pasta kits is being developed with Fareway to sell in Fareway stores.

Jennifer Hinrichs has been named manager of pasta production. The Steinkamps have been very helpful in getting pasta production in hand and will be on call as needed, Popenhagen added.

How did Amana learn about the opportunity? "I was contacted by a business brokering friend who knew I was looking to expand into food production within the Amana Colonies to strengthen our brand. Pasta is a delicious addition towards achieving the goal of simple, protein rich meals," Popenhagen explained.

Winterfest Frozen in Time

While Winterfest 2026 is in the books, just for the record, the first Winterfest was held Feb. 3, 2005, reports Allyn Neubauer, Amana.

Neubauer, then marketing director of the Amana Society and deeply involved in Amana festivals, created the event along with members of the Amana Convention and Visitors Bureau and the Amana

The first Amana Freezer Run was held in 2005 and organizers used hand held stop watches to record the 50 plus runner's times.

Charlie Hoehnle, Homestead, told us that he, his brother, Jack Hoehnle and George Mittlebach, Amana, walked in the first Amana Freezer Run. Mittlebach was 83 at that time and the oldest participant. Hoehnle became hooked on the 5K experience and did another 29 races in the area, including the next 17 Amana Freezer Runs. By his recollection, at no time was the race cancelled, but one year it was postponed for one week due to ice.

During Winterfest '05 blocks of ice were sawn by hand on the Mill Race as a demonstration event and packed in sawdust at the Amana sawmill by Larry Gnewikow.

Folks were asked to guess when those blocks would melt and Linda Setzer was the winner guessing correctly that they would last until May.

This year's Winterfest was one of the coldest residents can remember. The games of chance and the Amana Fire Department chili feed were moved to the Festhalle and people came, but the crowds were thin (if thickly dressed.) Perhaps best attended was the party in the Ox Yoke Inn's Bierstube and High Amana Room Saturday evening with entertainment by Jeff Weimer and David Arnold.

Amana Freezer Run Results

The official race records show it was -6 degrees at race time for Winterfest's Amana Freezer Run 2026. For a full list of all race results go to onlinera-ceresults.com Amana Freezer Run 2026.

Certainly the cold gave pause because in years past over 200 runners have participated. This year a total of 96 dedicated runners/ walkers came to the Freezer Run. The race winner was Jacob Blackmon, Cedar Rapids at 16 minutes, 24 seconds. Andrew Rompost, Coralville was second with 16 minutes, 45 seconds and multiple race winner Nathan Hopp was third posting a time of 17 minutes 25 seconds.

Emily Burmeister of Marion, was the overall female winner and also the winner of the 40 and over female age group.

Winning the 14 and under, male group was Elam Tiedt, Amana, who also cracked the top 15 of the race coming in 12th overall. Elam was the only Amana racer to make it into the top 15.

Racers came from as far away as Sun Prairie Wisconsin, with a fair number from Fairfield, Des Moines and Davenport.

IOWA COUNTY CAUCUS INFORMATION

Your local Caucus is an event where you can be directly involved in the democratic process. The Caucus gives community members an opportunity to be aware of and involved in the local party structure, platform, and upcoming events.

This year the precinct caucuses will be on Monday, February 2, starting at 7:00 p.m. (1900hrs).

All Iowa County Democratic Party precincts will meet at the Iowa Valley Junior-Senior High School 359 E Hilton St in Marengo in the lunchroom. Please use the front gym entrance or the back entrance and follow the signs.

Republican Party caucuses will be held by precincts.

- English II, North English City Hall
