# Portraying nature's wonders in art



An uncle who'd owned a few successful businesses also collected art. He once invited my newlywed wife and me to select something from a closet in his

Montreal penthouse as a wedding present. At the time, he was into Japanese drawings which dotted the living room walls. But the piece we chose from the stack leaning against his overcoats wasn't a total gift as we had to pay for the print by an obscure French painter. Still, it was a darn sight cheaper than the Matisse painting.

He ended up selling it all to pay for an upscale lifestyle, leaving nothing to anyone, including four children from two marriages. Interesting uncle; crappy father.

It was from him I developed a love of art, though sadly without the income to afford what I liked. Yet I've long harboured a deep appreciation for artists and musicians who enrich the world with their gifts.

### A purchase

So when I learned Brooklin is the home of an accomplished painter, I had to investigate. First, the end of the story. I bought an original piece from him as well as three small prints for my grandgirls. When I brought it home, the painting practically hoisted itself onto the wall.

Al Herrington's life story has more twists than could be recounted in a mere newspaper column. Consider this extremely shy child, born in Orillia who grew up in foster care. At age 10, his teacher asked him to draw something else because his first drawing of flowers was suspiciously good and she'd assumed it was done by a classmate. He completed the drawing, leaving the teacher aghast at his talent.

(That drawing became his first painting, done on the back of a Milk of Magnesia box, dated 1946. It was only recently framed and hung on his living room wall.)

#### Social worker's help

Herrington, now 87, recalls, "Somehow the word got back to my social worker that I could draw. She took me down to Yonge Street. She bought me all sorts of stuff. Pencils, pens, oils. A nice box to put my paints in. She loaded me up with all sorts of stuff and took me back to where I was staying with an older Scottish couple."

He completed his first oil painting commission at age 15 and by 17 was hired to do pen and ink sketches of historical buildings in north Toronto.

Then, with eyes on a career in electrical project design and engineering administration, he stopped painting after taking four years of high school art classes. In fact, when he got married, his wife Doris didn't know he was an artist until years later. Herrington says their three children never saw him paint.

Blessed with energy to burn and a self-professed proclivity to chat, his life during the painting-less years was full. His family lived in south Whitby at the time and he and neighbors were active in the community while he helped organize events and coached minor hockey.

### Starting again

Then, two years before retiring at age 59, he resumed painting, taking his art to festivals and shows all over Ontario where it often won awards. One larger work, "Watson's Marsh," was painted to honour a late friend, Jack Watson, with prints sold as fundraisers. It's also significant for him as its creation marked his return to active painting. It hangs in his living room, facing that first one from 1946.

"I had to produce enough art to be in those shows," he says. "I really had to work at it for a year to get enough."

A lover of nature, his work festoons his home including a studio packed with his art and prints.

#### Attention to detail


"When I was young," Herrington explains, "I painted in a much looser fashion. I don't anymore. My brain became conditioned for detail, detail, detail. I love nature. I developed an artist's eye."


As to his love of birch trees that feature in much of his work, he states that people ask if it's difficult to paint them. "Maybe if it's your first or second. Not so difficult if you painted thousands of them. It's like everything else in life. You get better at it. You learn from your mistakes."

I stroll about his house and studio, gawking. An unfinished painting he plans to return to sits on an easel. When it's done, I'd like to see it. Our house has room for another Herrington.

# **This Canadian First Was In Brooklin** By Jennifer Hudgins

Brooklin was at one time in the heart of a large farming district. And so it happened on Sept.8, 1949, that land owned by Heber Down became the location for Canada's first farm improvement and soil conservation Day.

Agricultural experts from colleges and the federal government were

concerned about the growing waste of fertile soil on Ontario farms due to wind and water erosion. Thus plans for a demonstration of ways to conserve the ecosystem to sustain plant life were put into place. Two hills of deeply eroded parcels of land owned by Heber Down were chosen from his 100 acre farm, lot 29, on the north side of Highway 7 in Whitby Township.

### Lots of visitors

For weeks, the event was widely publicized on the radio and in newspapers. One attendance estimate had 15,000 people who came to visit the farm, travelling by chartered bus or private cars from major agricultural areas as far away as Ottawa to the east and Windsor to the west. Local and provincial authorities provided the manpower and tools needed to carry out the improvements.

On that day, spectators watched half a kilometre of shrubbery bulldozed and cleared out. Jack Coates. who lived on the farm with his parents Dave and Alma, was a young boy and remembers the reaction from the crowd when a giant elm tree stump was blown out of the field with dynamite. The force was so strong that debris was thrown in every direction.



around the windward side of the field. A plan for crop rotation of wheat, barley, oats and corn was to be carried out over a five-year period to replenish lost nutrients.

However, improvements did not stop at the farmland. A new shed was also built to house farm tools and equipment to paint farm buildings. A remodelling of the farm house was done in a way to help conserve the time it took for Alma Coates to keep their home running efficiently. Soil around the house was landscaped with low maintenance perennial shrubs

and plants to minimize the need travellers could take note of the for frequent watering while flowering plants provided blooms to attract pollinators. The theory was that the more biodiversity there was in the garden, the less work the farmer's wife had to do.

All these elements worked together to bring about necessary changes and, although the farm has not been in use for years, today conservation agriculture is a worldwide practice.

We searched the racks for some middle ground, cute and trendy clothes designed for girls in transition from child to adult. When I found something more age appropriate, I got that look. You know, the one that implies you're old, out of touch and clueless about fashion.

In the end, we found jeans, a couple of shirts and even a dress that was originally scorned. After trying it on "just because you're making me," she decided it was "a slay." Translation: acceptable. She wore it to dinner that night.

Seemed mom does know a thing or two about style after all.

The hardest part of this shopping is talking about how clothes can give people the wrong idea of who you are. While teen girls want to look cool, there's a balance between being stylish without being too sexy.

Though fashion fights may seem to be about how much a top or pants reveal, they're often just about control. We need to remember that it's normal for teens to seek friction with their parents. Clothing choices are a safe way to do it.

So, how to make your point without a blow-up?

**Offer feedback calmly.** If you're really unhappy about the belly-revealing top, for instance, you'll get the greatest effect approaching it

How the conversation evolves depends a lot on your family's norms. Some parents might say, "You're not allowed to wear that." Others might give more leeway. The way to get it wrong is to just lay down the law without try-

ing to understand each other's positions. Or say nothing at all when it's clear the girl is wearing something completely inappropriate.

Find the win-win. A way to avoid clothing fights is to adopt a "mutual veto" rule while shopping together. Here, you and your teenager are allowed to veto clothing selections. You keep shopping until you find an item you both agree on.

this critical time in public education. Never before has ethical leadership been so central in addressing the unique and unprecedented challenges of the next four years: closing the learning gaps, supporting mental health concerns for both students and staff, addressing the violent incidents in our schools, many of which now include discriminatory practices targeting black, indigenous and people of colour, and advocating for funding for new schools to address the enrolment pressures.

We serve 75,000 students and nearly 10,000 staff across the district and we are one of the fastest growing boards in the province. This brings with it new opportunities to re-think and re-shape what the future looks like.



been a vegan for a long time and earned a level status from somewhere? Curious, I researched it and discovered most of this came from blogs, not well established vegan sites. It was interesting, if not a little divisive.

Level 1 - Vegans typically switch to the vegan diet for health benefits. Level 1 vegans may be aware of veganism's ethical and environmental benefits, but that is not their motivating factor. These vegans may also not be as strict with their vegan ethics, so they may still use non-vegan products such as leather or makeup tested on animals. A level 1 vegan will sometimes say, "I am mostly vegan."


Level 2 vegans may have more of a commitment to animal ethics than Level 1s. They may still occasionally purchase non-vegan accessories or clothing.

Level 3 - These vegans are pretty firmly entrenched in the lifestyle and are also much more aware of animal cruelty and rights. They may not be activists or draw hard lines around which restaurants they will eat in.

Level 4 - They are committed to veganism and follow a strict dietary regime. Level 4 vegans will often only eat out at yegan restaurants or a restaurant that clearly has a vegan option on the menu. They are also passionate
