Letter from the Manager

NOTICE OF INTENT FOR NOMINATIONS FOR THE BOARD OF DIRECTORS

Call for nominations to the Board of Directors. We would like to encourage our members who are interested in running for the Board of Directors to submit their Notice of Intent (attached to this newsletter) to the Association Office not later than 5:00 p.m. on the last Wednesday in November, which this year is November 29, 2017. If you are mailing in your Notice of Intent, I would suggest that you send it Return Receipt Requested to ensure that it was received by the cutoff date. You will also need to submit a one (8-1/2 x 11" page Candidate Statement not later than 5:00 p.m. December 10, 2017 with a photograph in order to have it included in the Annual Meeting Notice and your name included on the ballot.

Attention Pet Owners: The office has received a number of complaints regarding violation of the Association Pet Policy. As a reminder, our Covenants require that all pets must be control on a leash) at all times and not allowed to roam uncontrolled. A small child walking a big dog which may become aggressive when approached by another dog is not to be considered "controlled" or on a leash if the child cannot control the dog.

All animal waste (droppings) MUST be picked up and disposed of. This includes droppings on vacant lots and common areas and on your neighbor's lawn when walking your animal. Barking dogs or other animal sounds are required to comply with the noise Rule. Please be considerate of your neighbors.

Fall Cleaning: It is the time of the year when we are approaching full residency. While Hurricane Irma was kind to Oak Hollow, the storm certainly left us with some additional clean-up. Please take some time to examine your property for evidence of some required "Tender Loving Care". Some areas of concern are:

*Houses and wing walls shall be free of dirt, stains and mildew; *Broken or cracked stucco shall be repaired or replaced and painted.; *Torn or missing window, doors and lanai shall be replaced.; *Gutters , downspouts, fascia and shutters must be kept in good repair, all missing or broken pieces must be repaired or replaced: *Tree branches shall be kept to a minimum of seven feet above walkway, Dead branches shall be removed if hanging over a sidewalk and branches on the ground shall be removed.

Site Plan Reminders: Site plans are required for landscaping projects. The covenants required that no trees, bushes, shrubs or plants which at maturity and without clipping or pruning thereof, would exceed the height of the dwelling house on any lot shall be planted or emplaced until the plans and specifications for the placement of any such trees, bushes, shrubs or plants have been submitted to and approved by the Environmental Control Committee as to the preservation of the natural view and aesthetic beauty which each Lot and the community is intended to enjoy. Plans as submitted shall show in detail and to scale the proposed elevations and location of said trees, bushes, shrubs and plants, including the same in relation to all other Lots subject to these restrictions. Approval of landscaping plans may be withheld if in the opinion of the Committee, the view of any Lot would be impeded by the location of such tree, bush, shrub or plant. I,, hereby place my name in nomination as a candidate for the Board of Directors of Oak Hollow Property Owners Association Inc.
I understand that I must submit a Candidate Information Sheet that contains the information specified in the Oak Hollow Election Rules, Procedures & Political Campaigr Guidelines. I further understand that I am responsible for the accuracy of the information contained in the Candidate Statement.
I understand that, pursuant to Section 720.306(9)(b), Florida Statutes, I am no eligible for Board membership if I am delinquent in the payment of any fee, fine, or othe monetary obligation to OH for more than 90 days. I further understand that, pursuant to Section 720.306(9)(b), Florida Statutes, I am not eligible to serve on the Board of Directors if I have been convicted of any felony in this state or in a United States District or Territorial Court or any offense in another jurisdiction which would be considered a felony if committed in this state unless my civil rights will have been restored for at least 5 years as of the date of the Annual Meeting at which I seek election to the Board. By submitting this Notice of Intent, I attest that I will be eligible to serve on the Board of Directors as of the date of the Annual Meeting. I further consent to the Association conducting or having conducted a criminal investigation to verify compliance with Section 720.306(9)(b), Florida Statutes. I understand that every effort shall be made by the Association to maintain the confidentiality of the results of the criminal investigation However, by signing this Notice of Intent, I hereby waive and hold the Association harmless from any claim, action or suit regarding the criminal investigation.
