

**Sunday October 12th**  
**Willistown Troop 78 Navy & Marine**  
**250<sup>th</sup> Anniversary Day Trip**

**Overview**

Arrive at the cabin at 7:10 AM to take the Troop bus for a day of naval ship tours and veteran talks. We will start with a tour off the US Battleship NJ in Camden NJ and work to visit other in-service naval ships that are docked in Camden and Penn's Landing Philadelphia for the Navy Anniversary celebrations. We will be returning after 7PM to the cabin. Travel by Troop bus is mandatory for this trip. Travel between Philadelphia and Camden may be walking, bus ride, or water taxi based on crowds and weather. A simple bag lunch will be provided by the Troop. Bringing a snack for the bus trip back is recommended.

Because of the active-duty ship tours, there will be increased security when boarding ships and in the general area. Security will be like TSA (metal detectors and scans). All adults (ages 18 and above) MUST present a valid government ID. There are currently no ID requirements for minors. If any adult is not a US citizen, they will need to present a valid passport & they will also need to have their picture taken before boarding. You will not be allowed to carry string bags, knives, or water bottles. You may leave bottles on the bus.
