Mayor Hight called the meeting to order at 6:00p.m. Council Member Crumpton gave the invocation.

Mayor Hight asked for approval of the Council Minutes from March 2, 2020.

Terry Jackson explained to the Council that the Duckweed at the Lagoon was 90% in all ponds but pond number 4. He stated he had gone with Calvin and they can purchase a chemical that will kill it but it cost \$20 a gallon and they only sell it by 300 gallons the total cost will be \$6725.00.

Council Member Chapman moved to approve for Terry Jackson to order the Chemical to kill the Duckweed for \$6725.00. Council Member Collins seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Collins, Benson, Crumpton, and Chapman
