

Dumpster Rental Made Easy!

Terms & Conditions

By signing below, customer agrees to all terms and conditions listed and all charges accrued by the renting of this dumpster.

Rental Period is 7 days unless otherwise noted when order is completed. Customer must notify A-1 Hauling 48 hours prior to pick up date for extensions or any changes to pick up date. Any extension or rental period is subject to a per day fee that container is available. Customer understands to provide safekeeping of A-1 Hauling's rental containers, and is liable for any damage due to but not limited to graffiti, over spray, fire, dents, or damage.

Delivery and Pick-Up – A satisfactory payment of entire balance is required prior to delivery. Customer accepts and agrees to hold A-1 Hauling harmless against any claims for damages or loss of property, or injury resulting in use and possession of equipment. Responsibility of any damage done to driveways, lawn, overhead obstructions, and including but not limited to trees rests solely upon customer regardless of ownership or environmental conditions. Clear access to the container for the purposes of loading and unloading is required. Any blocked dumpster si subject to a fee. Customer grants A-1 Hauling the flexibility to pick up the dumpster when drivers are in the nearby area and understands that this could take several days, unless customer is willing to pay an additional pick-up fee.

Overweight – All costs from fines, excess landfill charges, or any improperly loaded container rests solely upon customer. Overweight dumpsters are subject to a fee per ton and shall not exceed 10 tons. Dumpster must be loaded evenly and level full. Any container that does not meet theses guidelines may be subject to an extra charge and reloading fee.

Unacceptable Items – Tree debris, yard waste, appliances, propane tanks, couches/mattresses, box springs, paint, batteries, tires, tractor tires, drums, hazardous materials, florescent lights, ash, fuel tanks, TV's, as defined by local, county, state, or federal regulation are not acceptable in any dumpster and are subject to extra charge. Any and all charges accrued by unacceptable items will be charged to customer's account.

Payment – All charges, permit fees, extra charges, overweight charges, and including any other charges can be charged to original form of payment without additional signatures provided. Any attorney/court fees that may incur from disputes is the responsibility of the customer and agrees to all costs and expenses associated with delinquency. All extra charges are in addition to the original amount indicated, and by signing this work order, authorizes all payments. Any updated, modified, or additional terms and conditions that are published and posted on A-1 Hauling's website are also binding by signing below. Customer agrees to view Terms and Conditions on website for cost of any additional fees.
