MAIL DELIVERY PROBLEM

Several residents in the single-family section of Coronado Hills have reported major problems with their mail delivery. Some complain about not getting their bank statements, credit card statements, missing packages, etc. If you have experienced any mail delivery problems in the past month, please contact **Mr. Vernon Kincey, Manager,** of the Northeast Post Office, 900 Blackson Avenue, at phone number (512) 419-7504, or **Mr. Shawn Lopez Supervisor,** at the same address. The Northeast Post Office is responsible for delivery of our mail.

NEIGHBORHOOD SPEEDING

The Austin City Council recently approved reducing speed limits to improve safety for all road users, including those riding bikes, walking and mobility impaired. Data collected by Austin Transportation Department's Vision Zero program shows that speeding is the primary contributing factor in one quarter of traffic crashes resulting in death. Neighborhood streets approximately 36 feet or less in width and have primarily front-facing residential land uses will be posted at 25 mph. Some neighborhood streets wider than 36 feet will also have reduced posted speed limits. While Glenhill Road is slightly wider than 36 feet (37 feet) it meets the definition of primary front-facing residential uses, it is anticipated that it will also have the limit of 25 mph. The fact that Glenhill also has two side streets at Raven and Shelbourne where the visibility is limited as you enter Glenhill makes any speeds over 25 mph hour dangerous. Please slow down on all the neighborhood streets and Coronado Hills Drive where the speed limit is 30 mph.

CURB APPEAL: HOW DO YOU RATE YOUR PROPERTY'S "CURB APPEAL?"

Coronado Hills/Creekside Neighborhood Association's Mission Statement is printed at the top of the first page

of every Newsletter. It's there to remind us that every resident has an obligation to help maintain our neighborhood's Safety, Integrity and Property Values. Any lack of attention to even one of these, will negatively impact the other two and will have a corresponding negative affect on the neighborhood in general.

Positive "Curb Appeal" is an important element in keeping up the neighborhood integrity and value of each homeowner's property. It reflects the attitude of the homeowner. It helps us to be proud of and to enjoy the appearance of all the homes in our neighborhood. It influences how neighbors feel about the attractiveness of homes on their block. It helps CH/CN to be appealing to our visitors and especially to those who may be looking for an attractive neighborhood in which to buy a home. Positive curb appeal enhances the value of your home, should you decide to sell it. According to APD, a neat, attractive, well kept neighborhood may discourage criminal activity.

Considering the importance of the above statements and based on the issues listed below: How do you rate YOUR home: Curb Appeal?

- Timely cutting of shrubs, grass, weeds growing over the curb. Clean up of same.
- Keeping trash and recycling bins behind a fence or out of sight of your front yard.
- Keeping long term storage of boats, campers, trailers on driveway or lawn, instead of behind your 6 ft fence
- Long term storage of unused, covered vehicles on your driveway, instead of behind your fence.
- Parking on the lawn, which is prohibited, in our neighborhood by City of Austin.
- Storage of misc. items, wood, building or repair materials on front lawns or driveways.
