Dear Guides,

Nature is a big part of Colorado and why visitors come here. When we take people around to show off our great natural resources, we tell the stories of how they were formed, how important they have been to our history, and how humans have dealt with the forces of nature. And who doesn't want to see an elk or bear along the way?

So, one subject that cannot be ignored is climate change. To omit the subject would be an injustice to those who came before us. After all, we know that climate forces were extremely influential to the Ancient Ones (Anasazi) of Mesa Verde abandoning their cliff dwellings. The stories of the Dust Bowl were important factors to our state and its agricultural importance. When you take several of the over 4.5 million visitors to Rocky Mountain National Park, I'm sure you tell them of the great glacier that formed Sheep Lakes and carved out Horseshoe Park. Climate change, past and present, is right there.

Therefore, the question is how we, as professional guides, approach this issue since there are still some who have denied it? We need to converse meaningfully and find out about their values, perspectives, and opinions. And since we are uniquely positioned with our immediate relevance to the visitor, we can advance the concept.

We know that many endangered species have been brought back from the brink. We can see the forests that have been devastated by beetle kill. There are smaller bits of glaciers tucked into the cirques. The rings around lakes are apparent.

As a guide, it is easy to remind guests to conserve water, use single-use plastics and recycle, emphasize how it is better that several are in one vehicle and not individual cars, consider walking trails instead of ATVs, avoid idling your vehicle, point out solar panels. You can do this without preaching.

Showing how you care about our environment will be the positive model for visitors, and because you love your state, you want to protect it. And show that you like the people so much that you want them to have an earth that we call all survive on.


