

## TOWN OF STRATTON STRATTON SCHOOL BOARD MINUTES OCTOBER 2, 2014

The Stratton School Board held its regular scheduled meeting on Thursday, October 2, 2014 at the Stratton Town Office. The meeting was called to order at 7:10 P.M.

ATTENDING: Thomas Montemagni, Chairman, Siobhan Eddy Young, Director, Lorraine M. Weeks-Newell, Secretary and WCSU Superintendent, Steven John.

## **BUSINESS:**

- 1) The minutes of the September 4, 2014 meeting were read. Lorraine Newell motioned to amend the minutes. Under Other Business the school year stated was 2014/2015 and should have read 2013/2014. The minutes were approved as corrected.
- 2) It was brought to the Boards attention that a family living in Stratton had enrolled their child in The Flood Brook School. The student attended school from 8/27/2014 9/12/2014 after which time they relocated to South Londonderry. There is a question of tuition payment for the period of time the student lived in Stratton and attended the school. As no information is on file for this student, the School Board requests that the family complete the Stratton Residency Packet to show that they were living in Stratton at the time their child attended school. Until this information is provided and approved by the Board, Stratton will not be responsible for tuition assistance.
- 3) Candie Bernard, Assistant Treasurer, contacted schools and provided the Board with an ADM, Average Daily Membership, of students. The 31 students were compiled in a list showing student, school and grade enrolled in.
