-Last week, a match took place in which I had ball-in-hand. My opponent informed me that I had stripes. Unfortunately, I was distracted and began shooting solids instead. I ended up running the table and pocketing the 8-ball before my opponent realized I was shooting the wrong group.

Because the IBL does not have a rule for this scenario, we mutually agreed to replay the match. Going forward, in situations where the IBL does not have a specific rule, we will default to the official rules of CueSports International. Effective immediately, the IBL has adopted the following rule to provide guidance for similar situations.

Once a group is established, groups can never change for the remainder of that game. If a player shoots the wrong group and no foul is called before the next shot and the player continues to shoot at that group, or if at any time during the game it is discovered by either player or a referee that the players are shooting the wrong groups, the game will be replayed with the player who broke the game breaking again. If a game has ended and then the players realize they shot the wrong groups, the game is not replayed, and the results stand.

-I will post the Official Rules of CueSports International to the website. Remember, these rules are only to be used if the IBL does not already have an established rule for a given situation.
