New Business:

- Replacement Street Sign & Lamppost
 - Recently completed as a result of the February accident. We filed a \$13,000 claim with the driver's insurance.
 - Haven't paid all the invoices yet, waiting to confirm everything is working. Will be closing out soon.
- Tree Maintenance
 - Couple quotes for maintenance this year. Contacted the same vendors as before.
 - Last year quotes ranged from \$6k \$13k. This year quotes ranged from \$5,400 to \$7k.
 - Agreed to a contract. Camilo and Andrew will be tagging trees tomorrow (8/5). We will prioritize fallen trees, trees close to houses, and other overgrown trees. Don't remove tags if you see them.
 - \circ Scheduled to complete the trimming next weekend (8/10).

Old Business:

- 2024 Street Resurfacing Q3
 - \circ We received three bids for this \$12k \$16k.
 - We previously used Sunland and signed a contract with them again this time. Looking for September with no official date.
 - We will be completing crack filling and adding two speed bumps on 23rd Place.
 - Will close parts of the community while this is done. More information to come.

Open Forum:

- Bulk trash has changed from quarterly to scheduled. We will send an email to ask people to contact the board if they schedule bulk trash pickup. We will also look into scheduling with the city so we can still have regular pickup.
- Trash can cleaning project was a success. We will look into scheduling twice a year and send a reminder at the same time for replacement cans via the city.
