

Ordinance Number 616

An ordinance appropriating certain money's .

Be it ordained by the mayor and commissioners of the city of Garnett Kansas.

Section One:- that the sum of *Three Hundred and Sixty Six and 1/2* <sup>(#366 1/2)</sup> ~~13/100~~ Dollars be and the same is hereby appropriated out of the General fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Four Hundred and Ninety Four and 3/4* <sup>and 3 3/4</sup> ~~100~~ Dollars be and the same is hereby appropriated out of Water Works fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Three:- that the sum of *Ninety nine and 29/100* ~~100~~ Dollars be and the same is hereby appropriated out of the Street fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Four:- that the sum of *Eight Hundred and Eighty nine and 68/100* ~~100~~ Dollars be and the same is hereby appropriated out of the Water Works Extension Bond fund 1913, in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Five:- that the sum of *Eleven Thousand Eight Hundred and Fifty and 1/100* ~~100~~ Dollars be and the same is hereby appropriated out of the Electric Light Bond Fund 1913, in the hands of the city Treasurer to pay the Bills allowed against said funds at a regular Meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Six:- that the sum of *Two Hundred and Twenty Nine and 68/100* ~~100~~ Dollars be and the same is hereby appropriated out of the Electric Light fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of January 1915. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Seven:- that the sum of Two & 00/100 (\$2.00)-----  
----- Dollars be and the same is appropriated  
out of the funds in sewer District Number One in the hands of the city  
Treasurer to pay the Bills allowed against said fund at a regular meeting  
of said Board held on the 4th day of January 1915. a list of which may be  
found on page of the Journal of the proceedings of said Board on  
said date.

Section Eight:- that the sum of One & 00/100 (\$1.00)-----  
----- Dollars be and the same is hereby appropriated  
out of the fund of sewer District Number Two in the hands of the city  
Treasurer to pay the Bills allowed against said fund at a regular meeting  
of said Board held on the 4th day of January 1915. a list of which may  
be found on page of the Journal of the proceedings of the Board on  
said date.

Section <sup>nine</sup>~~eight~~:- that the Mayor and city Clerk be and are hereby authorized  
and instructed to draw warrants on the city Treasurer to pay the Bills  
allowed in sections- one- two-three- four-five-six- seven- <sup>and eight</sup>  
of this ordinance.

Section <sup>ten</sup>~~nine~~:-this ordinance shall take effect and be in force from and  
after its passage by the Board of Commissioners and its approval by the Mayor.
