

# TOWN OF STRATTON VERMONT STRATTON SCHOOL BOARD MINUTES 9 W. JAMAICA ROAD, STRATTON, VT JUNE 26, 2018 7:00 P.M.

The Stratton School Board met on June 26, 2018 at 7:00 p.m. at the Stratton town Office to conduct end of the year school business for school year 2017/2018.

### **MINUTES:**

Minutes from the June 7, 2018 meeting were read. Lorraine Newell motioned to approve and Siobhan Young seconded. The minutes were approved.

### **RESIDENCY UPDATES:**

Ms. Carol Huber submitted her residency application at the June 7<sup>th</sup> meeting but it was found to be incomplete. She has since provided additional information to complete her file. The Board reviewed and approved her application for tuition assistance. Ms. Huber will be notified by mail of her approval.

### ACT 46

The Stratton School board received a letter from Jennifer D. Samuelson, Esq., chair of the Winhall School Board. The letter addressed scheduling a conversation with Stratton to determine its position on the Acting Secretary's proposed statewide plan for school district governance under 2015 Acts and Resolves N. 46. These findings were reported in the June 7, 2018 Stratton school minutes. Also stated in the letter was Winhall's feeling that it would be beneficial for the two districts to revisit merging as one district.

The Stratton Board addressed and discussed the contents of the letter and it was decided that Chair Montemagni would contact Ms. Samuelson by letter stating that considering Stratton's residents desire to remain an independent district it would not be productive for the two districts to meet.
